National Aboriginal Games

Lennard Morin – How were the Métis Youth selected? Were there any from Cumberland House at the games?

Louis Gardiner - The process was led by the FSIN which they have done for years. The information was sent to all the communities for try outs. Try outs were held and not many Métis attended. For the 2011 one of our goals is to ensure that we include more Métis delegation in coaching, management, chaperones, along with the athletes. We did have some athletes from Cumberland House make the teams, but some of them opted out to attend the Saskatchewan summer games in Lloydminster.

Recommendation – Lennard Morin paid the registration of \$500.00 for his grandson out of his own pocket. Lennard should send a letter to Louis Gardiner who will forward it to the appropriate party for re-imbursement.

Gabe - We need to start on a strategy so that the Métis Nation and communities will be more involved with the NAIG games.

Karen – There are bigger issues here, SaskSport will not provide funding due to past issues. Action Item 08-19-005 Louis Gardiner to send a letter to Minister Christine Tell requesting a meeting with the Youth Committee and the Executive regarding capacity money.
