Evan Shoforost referenced the Métis Nation – Saskatchewan Secretariat Inc. Financial Statements, March 31, 2017, and highlighted:

- Note 6 to the Financial Statements regarding contingent liabilities
- The audit report covers the period since the involvement of EY
- The 2017 surplus places the MN-S in a strong financial position
- The financial statements must be approved by the PMC for submission to the Ministry of Indigenous and Northern Affairs (INAC).

Mr. Shoforost referred the meeting to the information provided in the Agenda package and noted:

- Cash available in the MN-S and Back to Batoche accounts
- No Federal Government funding has been received, other than basic organization capacity (BOC) funding
- Committed amounts to be allocated from funding, which has not yet been received
- EY invoice for services rendered, which includes a significant professional discount
- Receivables from INAC of approximately \$3.41 million
- Anticipated surplus on March 31, 2018.

# **Request for Action**

Evan Shoforost agreed to provide documentation on the loan from Marc LeClair to PMC members.

During discussion, the following comments were offered:

- Clarification that the intention of Resolution 170626-06 was to provide \$5,000 for each region to fund the attendance of delegates at the Annual General Assembly (AGA) of Les Filles des Madeleine
- Need to ensure that \$60,000 is earmarked for Les Filles des Madeleine AGA
- Whether audited financial statements for the previous three years must be submitted to INAC in order to receive the committed federal funding:
  - Arrangements can be made to allow federal funding to flow although an audit opinion cannot be issued due to the lack of documentation
- The loan from Marc LeClair required to address the cash flow problem; a letter from INAC may be required to obtain a line of credit to address future cash flow issues
- The urgency of assigning a PMC member to be responsible for financial matters
- Whether the expenditure of \$60,000 to support to Les Filles des Madeleine is prudent, given the current cash deficit of the MN-S
- Whether the total travel costs being incurred by the MN-S are reasonable

# **Request for Action**

Evan Shoforost agreed to provide the trial balance and cash flow statement to Marg Friesen.

# It was MOVED (Mervin "Tex" Bouvier) and SECONDED (Leonard Montgrand)

That the Métis Nation – Saskatchewan Provincial Métis Council approves the Métis Nation – Saskatchewan Secretariat Inc. Financial Statement March 31, 2017, as presented.

- Suggestion that MN-S operations be maintained at core operations until funding is received from INAC
- Expectation that approximately \$500,000 will be received from INAC within one month of the audited financial statements being submitted.

Tammy Mah agreed to immediately recommend to Les Filles des Madeleine Board of Directors to postpone the AGA until the cash is available.

# **Consensus Decision**

By consensus, it was agreed to suspend arrangements for the board training session in Jasper, Alberta and to investigate other options, including local training.

During discussion, the following comments were offered:

- The PMC may be required to forgo some deposits that have been made for the Jasper board training session
- Importance of the PMC members understanding their fiduciary duties and personal liability.

Clarification was requested on factors used to determine the appointment of regional representatives to Métis-specific positions on an Enbridge oversight committee.

The PMC was reminded that it is not appropriate to raise regional issues at the PMC.

The Métis Nation – Saskatchewan Provincial Métis Council Regular Meeting reconvened at 2:22 p.m.

The following motion was passed at the September 23, 2017 In-Camera Meeting:

## It was MOVED (Leonard Montgrand) and SECONDED (Mervin "Tex" Bouvier)

**WHEREAS** in June 2017, the Métis Nation – Saskatchewan appointed a Minister of Economic Development with responsibility for the Clarence Campeau Development Fund (CCDF) and Saskmetis Economic Development Corporation (SMEDCO);

**WHEREAS** the Minister of Economic Development has taken an active role with SMEDCO, chairing its Board of Directors and participating in the governance of that agency;

**WHEREAS** to date, the Minister of Economic Development has been unable to obtain information or fulfill his duties in relation to CCDF on behalf of the MN-S and Métis people;

**WHEREAS** requests to meet with the CCDF CEO have been repeatedly denied and he has been referred to a subordinate employee; and

**WHEREAS** there have been a number of concerns raised with the CCDF governance structure and its relationship with the MN-S.

## THEREFORE BE IT RESOLVED THAT:

A. In light of these concerns, the Métis Nation – Saskatchewan Provincial Métis Council authorizes the Minister of Economic Development to contact the Provincial Minister responsible for the Saskatchewan *Gaming Corporation Act* to remedy the situation through the agreement between the MN-S and the Province that provides funding to the CCDF; and

- B. In the event a solution acceptable to the MN-S cannot be achieved, the Minister of Economic Development is hereby provided authority to cancel or amend the agreement with the Province accordingly; and
- C. The Métis Nation Saskatchewan Provincial Métis Council authorizes the public release of this resolution.
