Re: Preparation for the upcoming MNLA to be held on November 18-20, 2022

In preparation for the November 2022 MNLA and to ensure your participation, the following steps are outlined below. Send all information to the Office of the Clerk **before September 30, 2022**.

1. Locals:

Please submit the names of your duly elected President & Vice President including all documentation (Local minutes of last election, list of citizens who attended the meeting and who voted) to show that the election has occurred in accordance with Article 7 Paragraph 6 of the Constitution which states:


Each local shall be governed by an elected leadership as determined through the Constitution of the Local, which may include terms of one of three years and election may be by ballot box or conducted at a General Assembly of the Local Membership

a) Each Local shall submit the names of their elected leadership to the MN-S Head Office within 30 days of their election.

We realize that you may have already submitted this information to the head office but we humbly request that you submit the information to the Office of the Clerk to ensure that Local Presidents (or a Vice President as an alternative member of the MNLA in the event the President is not able to attend) are included in the Roll Call as in accordance with Article 2 Paragraph 2 of the Constitution and Article 3 of the Métis Nation Legislative Assembly Act (MNLA Act).

To be in good standing for the upcoming MNLA, you are required to submit all documentation directly to the Clerk of the MNLA at officeoftheclerk@mns.work by September 30, 2022.





2. Resolutions:

In accordance with Article 11 of the MNLA Act, please submit all resolutions concerning proposed amendments or legislative amendments by email to mnlaresolutions@mns.work by **October 18,**2022. The resolutions template and procedures can be downloaded at www.metisnationsk.com/mnla

In accordance with Article 12 of the MNLA Act, please forward any Constitutional Amendments to our office to be included in the Order of the Day by the Clerk. Constitutional Amendments have to be submitted no later than **November 4, 2022** to mnlaresolutions@mns.work Constitutional Amendments require that one of the following conditions be met:

- 12.1.1 Include approval by the Provincial Métis Council by virtue of signatures or resolution attached to the proposed constitutional amendment; or
- 12.1.2 Include approval by five (5) members of the MNLA by virtue of signatures attached to the proposed constitutional amendment.

Deadlines:

- New legislation October 18, 2022
- Constitutional Amendments November 4, 2022
