1. **CALL TO ORDER**

Vice President Gerald Morin, Chair, called the meeting to order at approximately 9:05 a.m. after confirming that a quorum was present.

4. REVIEW OF THE MINUTES

4.1 Approval of the March 16, 2021 PMC Minutes

Related information: Draft Minutes of the March 16, 2021, PMC Regular Meeting

Secretary Lisa McCallum read aloud the resolutions indicated in the draft minutes.

It was MOVED (Earl Cook) and SECONDED (Sherry McLennan)

That the Minutes of the March 16, 2021 Métis Nation – Saskatchewan Provincial Métis Council Meeting be approved, with an amendment to replace references to "trialling" with alternate text.

CARRIED (210420-03)

Wendy Gervais voted in opposition

4.2 Business Arising from the Minutes

The meeting recalled the March 16, 2021 discussion on the resolution to expand the Michif and Dene Early Learning Pilot Project into a full MN-S program, that could be implemented equitably across the province.

5. PROPOSED RESOLUTIONS

5.1 Appointing an Adjudicator and a Complaints Officer for the 2021 Election *Related information:*

- Draft Resolution for "Approving of Appointment of Adjudicator" labelled "For Internal Purpose and Not for Distribution" and dated April 20, 2021
- Draft Resolution for "Approving of Appointment of Complaints Officer" labelled "For Internal Purpose and Not for Distribution" and dated April 20, 2021

Richard Quintal, Chief Executive Officer, referenced the resolution passed at the March 16, 2021 PMC meeting to appoint Allan Brabant as Adjudicator and Marilyn Poitras as Complaints Officer for the 2021 Election of the MN-S and reported that both appointees declined the positions.

It was MOVED (Mervin "Tex" Bouvier) and SECONDED (Earl Cook)

WHEREAS it was recommended at this meeting of April 20, 2021, that the Provincial Métis Council (PMC) approve the appointment of John Hill to the Office of Adjudicator within the meaning of the Saskatchewan Métis Elections Act, 2007;

BE IT RESOLVED that the PMC hereby approves the appointment of John Hill to the position of Adjudicator, to adjudicate any complaints as may be referred by the Complaints Officer for the 2021 Métis Nation – Saskatchewan Election.

Marg Friesen and Sherry McLennan voted in opposition

It was MOVED (Mervin "Tex" Bouvier) and SECONDED (Sherry McLennan)

WHEREAS Gordon Kirkby was appointed by the Provincial Métis Council (PMC) to serve in the Office of Complaints Officer, within the meaning of the *Saskatchewan Métis Elections Act, 2007,* for the 2017 Métis Nation – Saskatchewan (MN-S) Election;

WHEREAS it was recommended at this meeting of April 20, 2021, that the PMC approve the appointment of Gordon Kirkby to the Office of Complaints Officer for the 2021 MN-S Election;

BE IT RESOLVED that the PMC hereby approves the appointment of Gordon Kirkby to the position of Complaints Officer, within the meaning of the *Saskatchewan Métis Elections Act, 2007,* for the 2021 MN-S Election.

CARRIED (210420-05)

Brent Digness, Wendy Gervais and Lisa McCallum voted in opposition

6. ELECTIONS 2021 EXPECTATIONS

Gwen LaFond, Chief Electoral Officer, provided an update on the status of preparations for the May 29, 2021 MN-S Election, and offered comments on:

- Training provided to Regional Returning Officers and Assistant Regional Returning Officers on April 9-11, 2021
- Establishing indoor polling stations at locations Métis citizens are familiar with, that are large enough to accommodate social distancing requirements
- The MN-S Election website (www.mnselection.ca), which will post information, including;
 - Confirmed polling station locations (once the election is called)
 - A list of all communities and their designated polling station locations
 - Confirmed nominees (on April 24, 2021)
- Adhering to the provincial COVID-19 pandemic safety standards and restrictions:
 - Barriers will be installed for the protection of citizens and polling station employees
 - Hand sanitizer, face masks and other protections have been arranged.

During discussion, comments were offered on:

- Rules for filing nomination papers with the Chief Electoral Officer, from April 24-29, 2021
- Securing polling stations indoors to keep materials safe from unexpected weather changes
- Complying with COVID-19 safety restrictions to protect MN-S employees and citizens
- Informing the Chief Electoral Officer of any emerging issues that may impact confirmed polling station locations (e.g. closures due to COVID-19 cases, etc.)
- Ensuring disinfection of all high-touch surfaces on a regular basis at the polling stations
- Social distancing signage provided by Elections Saskatchewan; rolls of tape were also provided to mark the floors to show people where to safely walk and stand
- The intent to hold four advance polls and a mobile poll in each region, with additional polls in more populated areas:
 - Voting will be open from May 14-21, 2021
 - The location of citizens, accessibility, and other criteria will be considered when determining polling station locations.

PMC members were invited to contact the MN-S Election website or the Chief Electoral Officer, for further information.

7. OTHER BUSINESS

7.1 COVID-19 Update

Marg Friesen, Minister of Health, acknowledged the new COVID-19 restrictions announced by Saskatchewan Health Authority (SHA) and offered comments on:

- Collaborating with the SHA to identify locations where MN-S citizens could access vaccines
- Continuing COVID-19 supports through the MN-S election period (e.g. providing isolating citizens with emergency food hampers, personal protective equipment, and other supplies)
- Vaccine clinic locations, posted on the SHA's website.

Additional updates were provided on:

- Mental health supports, including:
 - An ongoing strategy needed to support mental wellness and addiction recovery services
 - MN-S citizens' access to a 24-hour Mental Health and Addictions Crisis Line, offered through the Métis Nation of Ontario

- Assistance for MN-S citizens and their families, through a Saskatchewan-based Crisis Intervention Coordinator
- Opening the Recovery Lake land-based healing program by June 2021
- Services required by vulnerable citizens, including those who are homeless or transient
- Requesting frontline service providers to ask the Indigenous people they support, whether they identify as being First Nations or Métis, to improve the delivery of future services
- Benefits of potentially expanding the services offered by the Métis Addictions Council of Saskatchewan Inc. to include mental health services and 24-hour counselling
- The MN-S' medical transportation program, which was accessed with minimal complications.

During discussion, comments were offered on:

- Concerns related to Métis citizens not being prioritized for vaccinations in Saskatchewan
- The vaccine clinic scheduled at the MN-S Office in Saskatoon, on April 23 and 24, 2021
- Appreciation to the Meadow Lake Tribal Council, Saskatoon Tribal Council and other Indigenous communities for including Métis citizens in their vaccine rollout
- An upcoming MN-S press release to announce Indigenous vaccination sites.

7.2 Elders Gathering

Sherry McLennan, Minister of Culture, Language and Heritage, acknowledged the April 17, 2021 virtual Elders Gathering, and noted that:

- Approximately 40 Knowledge Keepers and Elders attended the Gathering
- Information was shared and gathered in separate breakout sessions, focussed on language, harvesting, protocols and honouring Elders
- An Elders Symposium will be held in 2022; Regional Chairs could send the MN-S Office a list of Knowledge Keepers and Elders in their regions, to be invited to future Elders events
- Some Knowledge Keepers and Elders did not receive an emailed invitation to the Gathering, and requested they be invited to future events.

7.3 Ministerial Transition Binders

Related information: Briefing note titled, "Ministerial Transition Binders", dated April 16, 2021

Richard Quintal confirmed that Ministerial transition binders would be finalized during the writ period, to present to new and re-elected Regional Chairs, post-election.

Regional Chairs were encouraged to include important information in their transition binders, such as financial information, and contact details for the person overseeing COVID-19 supports in their region. They were further reminded that before April 29, 2021, any car rentals must be returned, and any MN-S assets must be locked in their Regional Office. After April 29, 2021, they could no longer access their Regional Offices.

Regional Chairs were informed of their fiduciary obligations and the importance of acting in the best interest of the MN-S.

In response to guestions raised, the following comments were offered:

- Salaries will continue to be paid to current elected officials until May 29, 2021
- Indigenous funding announced in the federal budget was for infrastructure, health, economic development, early learning and childcare, and mental health and addiction supports

- Further details on the federal budget announcement are expected at upcoming meetings with Indigenous Services Canada and Canada-Indigenous Relations and Northern Affairs Canada.

During discussion, commendations were extended to:

- MN-S elected representatives and senior officials for supporting the Health Accord
- Those involved in the Permanent Bilateral Mechanism discussions with government
- The accomplishments, accountability and transparency of the MN-S and the current PMC.

Request for Action

It was requested that Riva Racette send an email to the Provincial Métis Council confirming whether they will be eligible to collect Employment Insurance benefits, if they are not re-elected.

7.4 Métis Women and Métis Youth

Clarification was requested on why an officially elected women's representative was not recognized by the Métis Women.

During discussion, comments were offered on:

- Funding allocated by the MN-S for the Métis Women and the Métis Youth
- The importance of the Métis Women and Métis Youth representatives participating at PMC meetings and providing updates on priority issues
- Reviewing the roles and responsibilities of the Métis Women and Métis Youth at a future PMC meeting.

Jaycee Bell, Métis Youth Council, confirmed that the Métis Youth Council would meet on April 21, 2021. An online election, open to participants from across the province, will be held before July 31, 2021.

8. CONCLUSION AND CLOSING PRAYER

The meeting concluded at approximately 11:30 a.m. with a Closing Prayer offered by Elder Fleury.

1. CALL TO ORDER

President Glen McCallum called the meeting to order at approximately 10:10 a.m. after confirming that a quorum was present.

2. OPENING PRAYER

Elder Norman Fleury offered an Opening Prayer.

3. APPROVAL OF THE AGENDA

5. OPENING REMARKS – PRESIDENT MCCALLUM

A round of self-introductions ensued, to welcome the newly elected officials to the PMC. The importance of working together as a unified government, with accountability to MN-S citizens was emphasized.

President McCallum congratulated PMC members on their recent election by MN-S citizens and offered comments on:

- The MN-S' progress from a non-profit organization to a self-government
- The importance of working at the PMC table in solidarity and building trust through transparency and accountability to MN-S citizens
- The approval of the Handbook by the Métis Nation Legislative Assembly (MNLA) with the intent to set accountability standards for the Executive, Ministers and PMC members
- Acknowledgement of past Métis leaders, who created the pathway for the MN-S to become a strong Indigenous government.

In response to a point of order, it was confirmed that motions should be duly moved and seconded, before discussion on the motion ensues.

It was MOVED (Michelle LeClair) and SECONDED (Wendy Gervais)

That the Minutes of the April 20, 2021 Métis Nation – Saskatchewan Provincial Métis Council Meeting be approved, with the following amendments:

- Resolution 210420-04: Marg Friesen and Sherry McLennan voted in favour of the resolution and will be removed as voting in opposition; and
- Resolution 210420-05: Brent Digness voted in favour of the resolution and will be removed as voting in opposition.

4.2 Business Arising from the Minutes

This item was not considered.

6. REPORT FROM THE MN-S EXECUTIVE

6.1 Report from the June 1, 2021 Executive Meeting

Secretary McCallum reported that members of the Executive (Vice President LeClair, Treasurer LaFontaine and Secretary McCallum) met on June 1, 2021 to discuss the role of the Executive, as per the *Constitution of the Métis Nation – Saskatchewan* (the "Constitution"). President McCallum was unable to attend the meeting.

Secretary McCallum reviewed the following recommendations arising from the June 1, 2021 Executive meeting:

- That the Handbook be reviewed
- That the Executive meet on a more regular basis throughout the year
- That a Transition Team be assigned to assist with the integration of newly elected officials
- That a retreat be scheduled for the PMC to build unity and discuss pathways forward.

President McCallum recognized the importance of the PMC having governance training, and the regions working together effectively. It was confirmed that PMC members were requested to provide their resumes to assist in the Ministerial appointment process.

Change in Chair

President McCallum asked Vice President LeClair to assume the role as Chair at approximately 11:45 a.m.

During discussion, comments were offered on:

- Potential items for the PMC retreat agenda:
 - o Governance training, with procedures and protocols for conducting meetings
 - Communications training
 - A Healing Circle, supported by Elders
- Changes to the Constitution anticipated, as the MN-S transitions towards self-government
- The role of the Chief Executive Officer (CEO) and MN-S staff
- Human Resource policies established with protections for MN-S staff
- Including senior staff at the PMC retreat, given their integral role in transitioning the MN-S to self-government.

Health Break

The meeting recessed at 12:00 p.m. and reconvened at approximately 1:00 p.m. President McCallum assumed the role as Chair.

6.2 The Handbook for Executives, Ministers and Members of the PMC

Vice President LeClair offered comments on the Handbook and suggested that consideration be given to the following:

- An independent legal review, to provide clarity on the expectations of conduct, responsibilities, breeches and disclosure requirements
- Including clear definitions of terms throughout the Handbook
- Seeking legal consultation prior to signing disclosure forms.

During discussion on a draft resolution presented to establish a technical committee to review the Handbook, comments were offered on:

- Consent to add a friendly amendment to state that the Handbook was a living document intended to provide foundational guidance on matters of good governance and protocol
- Requiring approval of any amendments to the Handbook at a MNLA
- Incorporating progressive and incremental disciplinary actions in the Handbook
- Including representation from the North, Central and Southern regions on the technical committee
- Financial implications of legal or disciplinary actions against a Minister, Executive or PMC member
- The Declaration of Assets, which only pertains to assets that could present a conflict for a Minister, Executive or PMC member while carrying out their fiduciary duties
- Options for enforcing the guidelines outlined in the Handbook
- Potentially including a review of the Handbook at the PMC retreat
- Obligations that the PMC were subject to, which are informed by Common Law (e.g. fiduciary duty, duty of care, duty of confidentiality, etc.).

It was MOVED (Marg Friesen) and SECONDED (Leonard Montgrand)

WHEREAS the Métis Nation – Saskatchewan (MN-S) Provincial Métis Council (PMC) is dedicated to collective governance based on procedures, protocols and practices grounded in good governance, accountability and transparency;

WHEREAS the *Handbook for Executives, Ministers and Members of the Provincial Métis Council* ("the Handbook") is a living document intended to provide foundational guidance on matters of good governance and protocol;

WHEREAS the continued development of the MN-S government requires ongoing and continuous improvement and refinement to more perfectly achieve its vision of an open, transparent government for the benefit of the Métis people of Saskatchewan;

NOW THEREFORE BE IT RESOLVED at this meeting of June 18, 2021, that the PMC direct the MN-S Chief Executive Officer to establish a technical review committee to review the Handbook and develop recommendations for its continued refinement, improvement and enhancements to support good governance and sound process to support the work of the MN-S government;

BE IT FURTHER RESOLVED that the technical review committee be mandated to engage with members of the PMC, governance experts, and Elders to identify areas of concern and develop recommendations for the future consideration, deliberation and approval of the PMC.

President McCallum asked Vice President LeClair to assume the role as Chair at approximately 2:30 p.m.

7. PROPOSED RESOLUTIONS

7.1 Appointment of the Minister of Finance

Related information: Draft "Resolution to Approve Appointment of Minister of Finance", labelled "For Internal Purpose and Not for Distribution" and dated June 18, 2021

The draft resolution was read aloud. During discussion, comments were offered on:

- An understanding that the elected Treasurer was also the MN-S' Minister of Finance
- The *Constitution's* reference to designating "persons who may have signing authority for the purpose of conducting the affairs of the organization, which shall include the Treasurer"
- Marg Friesen's experience on the Finance Committee, including:
 - o Administering Emergency COVID-19 funding as the Minister of Health
 - Overseeing financial obligations in a transparent manner
- The prior appointment of Marg Friesen to the Finance Committee (without a motion)
- The Treasurer's experience with the Provincial Métis Housing Corporation (PMHC), and his assertion that a Statement of Claim filed by the PMHC against him, included false information:
 - As the Statement of Claim was "noted for default", it was deemed an admission by the defendant, that all matters presented in the Statement of Claim were true
 - The Statement of Claim was ruled to be "complete".
- Providing resolutions to the PMC in advance of future meetings, to support informed decision making.

NOW THEREFORE BE IT RESOLVED THAT the PMC at this meeting of June 18, 2021, hereby approves the assignment of Marg Friesen, Regional Director for Eastern Region 3, to the Finance Portfolio, to serve as the Minister of Finance for the Métis Nation-Saskatchewan.

7.3 Affirming the Collective Responsibility of the Provincial Métis Council

A friendly amendment to the draft resolution was proposed to indicate that "as the Executive Branch of the MN-S, the PMC confirms its collective responsibility and commits that all decisions must be approved by a 75% majority of members". The Mover and Seconder of the resolution did not consent to the proposed friendly amendment.

Point of Order

In response to a point of order requesting that the resolution be tabled to the next PMC meeting, the Mover and Seconder did not consent to postponing its consideration.

WHEREAS the Métis Nation – Saskatchewan ("MN-S" and/or the "Nation") utilizes a consensus based model for governance that is grounded on the principles of solidarity and collective responsibility;

WHEREAS the *Constitution of the Métis Nation – Saskatchewan* ("the *Constitution*") is the voice and deepest expression of the Nation's values, identity and rights as a self-governing Métis Nation;

WHEREAS the *Constitution* establishes the foundation for good governance and sets the expectations, requirements and conduct of government in a manner that benefits the entire Nation;

WHEREAS the *Constitution* establishes two branches of government, the Legislative Branch and the Executive Branch, which are the contemporary expressions of our governing structures;

WHEREAS the Métis Nation Legislative Assembly is expressly identified in the *Constitution* as the governing authority and is given powers as the Legislative Branch to enact legislation and ratify decisions;

WHEREAS the Provincial Métis Council (PMC) is expressly identified in the *Constitution* as the Cabinet and is given powers as the Executive Branch to administer and implement the policy of MN-S.

NOW THEREFORE BE IT RESOLVED at this meeting of June 18, 2021, that the PMC confirms its collective responsibility as the Executive Branch of the MN-S government and commits to fulfilling its decision-making role in a manner consistent with the intent of the *Constitution*.

6.3 Île-à-la-Crosse Boarding School

Further to discussion in the earlier in-camera session, the following motion was presented for consideration:

It was MOVED (Lisa McCallum) and SECONDED (Mervin "Tex" Bouvier)

WHEREAS the Métis Nation – Saskatchewan (MN-S) is the exclusive representative government of all Metis of Saskatchewan;

WHEREAS MN-S government has established a Ministerial office and portfolio dedicated to advancing the rights and interests of Métis survivors of residential school who have been unjustly excluded from recognition by both the provincial and federal governments; and

WHEREAS MN-S desires to pursue federal funding to establish a Commission to promote education and recognition of the harms sustained by Métis survivors of residential school, to make meaningful recommendations to advance reconciliation and to address the intergenerational trauma sustained by their families.

NOW THEREFORE BE IT RESOLVED that the Provincial Métis Council approves of the establishment of a Commission whose mandate will be to, *inter alia*:

- document the history of Métis students in Saskatchewan in day schools, industrial schools and residential schools to better understand the experience of Métis students, including historic injustices;
- build on the work of the residential school survivors of Île-à-la-Crosse and elsewhere by including all former residential students and schools in Saskatchewan;
- examine the roles of the Government of Saskatchewan, the Government of Canada, and the churches in the administration of the schools;
- provide an opportunity for residential school survivors and families to preserve their stories and to ensure that their voices will be heard;
- provide meaningful and accessible support to survivors and their families in their healing journeys;
- research and document the stories of our lost Métis children who attended schools, including the identification of gravesites for those children who did not return home; and
- develop a Terms of Reference for the Commission, which addresses areas left unexplored by the Truth and Reconciliation Commission mandate with regards to Métis people.

BE IT FURTHER RESOLVED that the Commission will consult with an Advisory Committee that consists of survivors and their families, who will inform and guide the work of the Commission – to ensure forward progress of the work done to date.

BE IT FURTHER RESOLVED that MN-S shall pursue funding to establish the Commission and implement its mandate.

6. **LEGAL UPDATE (Continued)**

6.1 **Self-Government**

Further to discussion in an earlier in-camera session, the following motion was presented for consideration.

It was MOVED (Mervin "Tex" Bouvier) and SECONDED (Marg Friesen)

WHEREAS the Metis Nation – Saskatchewan (MN-S) is the exclusive representative government of all Metis of Saskatchewan;

WHEREAS MN-S and Canada executed a Métis Government Recognition and Self-Government Agreement (the "MGRSA") on June 27, 2019, which among other things, affirmed MN-S as the exclusive representative and Section 35, Constitution Act, 1982, (S.35) government of all Metis of Saskatchewan;

WHEREAS on July 6, 2021, Canada and Manitoba Metis Federation Inc. executed the Manitoba Métis Self-Government Recognition and Implementation Agreement (the "MMF Agreement");

WHEREAS the MMF Agreement is fundamentally at odds with the MN-S MGRSA and with Canadian law;

WHEREAS Canada did not consult with MN-S in negotiating and concluding the MMF Agreement despite its clear potential impact on MN-S and its citizens; and

WHEREAS the Provincial Metis Council (PMC) desires to declare its collective opposition to Canada's conduct in negotiating and concluding the MMF Agreement which is inconsistent with the MGRSA and the constitutional principle of the honour of the Crown.

NOW THEREFORE BE IT RESOLVED that the PMC, as the Executive Branch and Cabinet of the MN-S, hereby affirms its collective responsibility to advance the rights and interests of all Metis of Saskatchewan, including those rights recognized and affirmed by S.35 of the Constitution of Canada.

BE IT FURTHER RESOLVED that the PMC shall take all measures to prevent any government action that would purport to limit the MN-S' jurisdiction and inherent rights of self-determination and self-government.

BE IT FURTHER RESOLVED that the PMC shall hold Canada accountable for all of the commitments set out in the MGRSA, its constitutional obligations and its common law obligations, including its obligation to uphold the honour of the Crown.

Kathie Pruden Nansel, Minister of Child and Family Services, requested a timeframe for an election for Les Filles de Madeleine (LFDM). Additional comments were offered on:

- LFDM as a separate entity from the Ministry of Women and Gender Equality
- Following the same process as the Provincial Métis Youth Council election
- Concerns related to the exclusion of some Regions from LFDM
- Reviewing MN-S' financial obligations to LFDM through the constitutional reform process
- The *Constitution of the Métis Nation Saskatchewan* reference to the Métis Women of Saskatchewan; and the provision for a seat at the PMC, which would cease once Women achieve equitable representation at the table.

10.3 MN-S Retreat

Richard Quintal, Chief Executive Officer, informed that a retreat was being planned for the week of August 23, 2021. The retreat would include a Ministerial meeting with presentation of mandate letters, and the participation of Directors, Senior Administrative staff, Elders, Veterans and a Dumont's Scout. It was suggested that the August 17, 2021, PMC meeting be postponed to take place as part of the retreat.

5.1 Approval of the July 20, 2021 PMC Minutes

Provincial Secretary McCallum read aloud the resolutions included in the minutes.

5.2 Business Arising from the Minutes

During discussion on the minutes, Richard Quintal, Chief Executive Officer, read aloud an August 13, 2021 letter received from the Minister of Crown-Indigenous Relations, which:

- Affirmed the Government of Canada's (Canada's) commitment to work with the MN-S, to implement the June 27, 2019, Métis Government Recognition and Self-Government Agreement (MGRSA), based on the recognition, affirmation, and implementation of Métis rights protected by section 35 of the *Constitution Act*, 1982 (Constitution)
- Announced that an Interim Fiscal Financing Agreement had been finalized, in the amount of \$21,931,317 to implement the MGRSA further, and the commitments made to advancing self-determination for the Métis Nation within Saskatchewan
- Confirmed Canada's commitment to work with the MN-S to establish predictable multi-year funding for continued negotiations and to explore claims against the federal Crown
- Addressed the MN-S' concerns about potential impacts of the July 6, 2021 agreement that Canada signed with the Manitoba Metis Federation (MMF), which defined "Manitoba Métis" as only "one of the Métis collectivities that together make up the Métis Nation"
- Canada's willingness to prioritize collaboration with the MN-S, to seek the mandates needed to apply the federal rights-recognition policies and techniques employed in the MMF-Canada Agreement, to Canada's agreements with the MN-S.

President McCallum acknowledged supports outlined in the letter and emphasized the importance of remaining focused on the MN-S' continued progress.

During discussion, comments were offered on the September 20-23, 2021 PMC Retreat in Kananaskis, Alberta, regarding:

- Holding the MN-S Retreat virtually if necessary, due to pandemic restrictions
- Transitioning from a not-for-profit structure to a self-government
- Reminding PMC members to vote in advance polling for the federal election
- Potential agenda items for consideration, including:
 - The Canada-Métis Nation Accord and the Permanent Bilateral Mechanism
 - Negotiations to Support Île-à-la-Crosse Boarding School Survivors
 - The August 13, 2021 Letter from the Minister of Crown-Indigenous Relations
 - o MN-S Funding, Infrastructure, Program Delivery, Workplans, Policies and Staff Salaries
 - The MN-S Governance Structure (including the Métis Women of Saskatchewan and the Provincial Métis Youth Council)
 - $\circ \quad \hbox{Constitutional Reform and Community Engagement Processes}.$

It was noted that an online election process was planned for the Provincial Métis Youth Council. The election date will be conveyed to the PMC (likely August 23, 2021).

It was MOVED (Lisa McCallum) and SECONDED (Leonard Montgrand)

Richard Quintal reviewed the intent of the draft resolution to approve the purchase of two properties intended for establishing a La Faamii programs and services hub, where Métis citizens and families could access culturally relevant supports and services. Matt Vermette's involvement in the project, was acknowledged.

The draft "Resolution to Approve Purchase of Real Property", was read aloud.

During discussion, the following comments were offered:

- The project was initiated by the prior administration to address gaps in programs and services:
 - The Finance Committee supported the fiscal decision to purchase the property
 - Funding was negotiated for the project to support families after the pandemic
- A total of \$1,539,961.50 was offered to acquire Unit 113 and Unit 223 at 123 Avenue B S, Saskatoon, Saskatchewan; the PMC's approval is a condition of the purchase proceeding
- A full business plan and facility model will be prepared if the purchase proceeds:
 - One of the units is situated on the ground floor, and the other is directly above
 - The MN-S would own both units, which could potentially be resold in the future as combined or separate assets
 - Photos of the properties could be provided.

Request for Action (RFA-210817-01)

The Finance Committee agreed to prepare a briefing note for the Provincial Métis Council, with information on all properties the Métis Nation-Saskatchewan currently owns.

WHEREAS it is the desire of the Provincial Métis Council (PMC) to establish a programs and services hub for Métis citizens and their families as part of La Faamii pilot project initiative;

WHEREAS the establishment of La Faamii programs and services hub will ensure that Métis citizens and families can access culturally-relevant supports and services;

WHEREAS the Métis Nation - Saskatchewan (MN-S) Ministry of Child and Family Services has identified certain real properties located at #113 and #223 of "the Blok" at 123 Avenue B S in Saskatoon, Saskatchewan (the Property), that will be a suitable site for the establishment of La Faamii hub, as described above;

WHEREAS on July 14, 2021, an offer for purchase of Unit #113 – 123 Avenue B S was presented to the owners of the Property in the net amount of \$771,750.00 (including GST);

WHEREAS on July 14, 2021, an offer for purchase of Unit #223 – 123 Avenue B S was presented to the owners of the Property in the net amount of \$768,211.50 (including construction credits and GST);

WHEREAS the total amount being offered to acquire both properties is \$1,539,961.50;

WHEREAS the aforesaid offers were conditional on inter alia obtaining the approval of the PMC within sixty days of acceptance of the conditional offer;

WHEREAS the conditional offer was accepted on July 16, 2021, and the deadline for obtaining the approval of the PMC shall expire on September 10, 2021; and

WHEREAS the Ministry of Child and Family Services has recommended to the PMC that the Property be purchased as the site of La Faamii services hub at this duly convened meeting of August 17, 2021, subject to satisfactory completion of all necessary due diligence inquiries.

NOW THEREFORE BE IT RESOLVED that the PMC hereby approves of the purchase of the properties located at 113 and 223 of "the Blok" at 123 Avenue B S in Saskatoon, Saskatchewan, as presented at this meeting of August 17, 2021, as the future site of La Faamii hub of programs and services, subject to satisfactory completion of all necessary due diligence inquiries and removal of associated conditions.

Christena Konrad, Director of Housing, reviewed the information provided on the Homelessness Strategy and commented on:

- Key objectives of the program, including connecting vulnerable Métis citizens in Saskatchewan to existing housing and support services available
- The intended delivery model for the program, including:
 - Hiring staff as required to support citizens who need access to services
 - o Training staff to teach Rental Education, Basic Home Maintenance and Personal Budgeting
 - Expanding available services, including:
 - · Allocating funds to continue the Medical Transport Program
 - Creating a "Rent Bank" providing citizens with access to funds to cover rental arrears
 - · Providing emergency access to food, housing set-up costs, etc.
 - Supporting those reintegrating from the provincial and federal justice systems
 - Coordinating with existing homelessness efforts and services across the province
 - The four-year budget plan.

In response to questions raised, the following comments were offered:

- The Homelessness Strategy is a community initiative, that will ensure there are staff across the province, with access to a list of programs and services available
- The Housing Ministry will allocate the program funding as needed, across the province.

It was MOVED (Ryan Carriere) and SECONDED (Laura Burnouf)

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes that homelessness afflicts many of our citizens, limiting their ability to participate fully in society and fulfill their personal potential;

WHEREAS the MN-S is committed to reducing and, where possible, eliminating homelessness among our citizens by building a comprehensive housing and homelessness strategy and programming;

WHEREAS the MN-S has entered into an agreement with Employment and Social Development Canada to address homelessness with a plan to administer a four (4) year Reaching Home: Canada's Homelessness Strategy Métis Distinction-Based Funding Agreement;

NOW THEREFORE BE IT RESOLVED that the Provincial Métis Council (PMC) approves the "MN-S Homelessness Strategy: Reaching Home", as presented; and

BE IT FURTHER RESOLVED that the PMC approves a four (4) year budget for expenditures on the strategy totalling \$4,838,616, allocated as follows:

- \$891,000 for fiscal year end 2021;
- \$1,315,872 for fiscal year end 2022;
- \$1,315,872 for fiscal year end 2023; and
- \$1,315,872 for fiscal year end 2024.

7.2 Confidentiality Issues and the PMC

Related information (provided with the agenda): Draft "Resolution Prohibiting the Disclosure of Proprietary and Confidential Information", labeled "For Internal Purpose and Not for Distribution" and dated September 21, 2021

Vice President LeClair expressed concerns related to the recent release of confidential PMC communications, constituting a breach of PMC members' oaths of office and fiduciary duties. Discussion ensued on initiating an internal investigation into the confidentiality breach and considering disciplinary action, which may include suspension from the PMC for a period of time.

Request for Action (RFA-210921-01)

It was requested that the next Provincial Métis Council (PMC) meeting receive the terms of reference, membership list and a progress update from the Technical Review Committee, which was established by the PMC on June 18, 2021 to review the "MN-S Handbook for Executives, Ministers and Members of the Provincial Métis Council".

It was MOVED (Michelle LeClair) and SECONDED (Marg Friesen)

WHEREAS the Provincial Métis Council (PMC), at its duly convened meeting on June 18, 2021, passed a resolution affirming the importance of having a model for governance that is grounded on the principles of solidarity and collective responsibility;

WHEREAS the elected members of the PMC form the Cabinet of the Métis Nation – Saskatchewan (MN-S) government and make decisions affecting the rights and interests of the MN-S and its citizens;

WHEREAS members of the PMC have access to proprietary, classified, confidential and privileged information, which if disclosed to third parties could harm MN-S' rights and interests;

WHEREAS members of the PMC owe fiduciary duties of loyalty and good faith and are obligated to protect confidential information as part of those fiduciary duties; and

WHEREAS internal communications of the PMC were shared with an external third party on or about September 2, 2021.

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The PMC, at this duly called meeting of September 21, 2021, desires to denounce and expressly prohibit the sharing and disclosure of MN-S' confidential information;
- 2. The disclosure of MN-S' confidential information constitutes a material breach of PMC members' oaths of office and fiduciary duties of loyalty, good faith and confidentiality;
- 3. Any member of the PMC who discloses confidential information is committing a seditious act and shall be held accountable to the fullest extent of the law. Disciplinary action may include but is not limited to, the loss of Ministerial responsibilities, removal from internal committees and the matter being brought before the Métis Nation Legislative Assembly (MNLA);
- 4. For the purposes of this resolution, "confidential information" means any information of a confidential nature which relates to the business and activities of the MN-S and its affiliates, including, without being limited to, the following:
 - a) information that is proprietary or sensitive in nature;
 - b) information that is identified, marked or communicated as "privileged" and/or "confidential";
 - c) information that is communicated for internal purposes;
 - d) documents, plans, and communications that are in draft form;
 - e) business and legal strategies, technical plans, personnel information, and related information;
 - f) information relating to and regarding clients, legal files, negotiations with third parties and/or customers and/or program beneficiaries of the MN-S and its affiliates; and
- 5. The PMC further directs that there be an internal investigation to determine the source of the unauthorized disclosure, that the logistics of the internal investigation be determined by the MN-S' Human Resource Committee, and that recommendations based upon the investigation findings be presented to the PMC for its consideration and deliberation.

CARRIED (210921-05)

Change in Chair

Vice President LeClair resumed the role as Chair at 12:05 p.m.

7.3 Conflicts with External Organizations

Discussion ensued on the potential impacts of external agencies and organizations, that may seek to support or engage with Métis citizens and communities in Saskatchewan.

In response to questions raised, it was acknowledged that:

- It is the MN-S' role to represent the province's Métis citizens
- The MNLA's role as governing authority of the MN-S is to enact legislation, regulation, rules and resolutions governing the affairs and conduct of Métis in Saskatchewan
- Judicial Review Committee meetings may resume, when pandemic restrictions allow.

Health Break

The meeting recessed at 12:30 p.m. and reconvened at 1:05 p.m.

8. FINANCE UPDATE

Marg Friesen, Minister of Finance, provided a "Finance Update" and commented on:

- Audit processes initiated by all MN-S Regions
- Releasing Regional capacity funding (for the first and second quarters of 2021) within the next two weeks, to enable Regions to manage their operational and other costs; some Regions were still in the process of completing their audits
- Preparation of a Ministry of Finance communication, outlining who can access temporary COVID-19 relief support funding
- The draft MN-S Budget, which will be presented to the PMC prior to its implementation
- Streamlining internal processes and financial controls to continue to support transparency
- Progress on a policy being developed for MN-S' contractors and consultants
- Including "Finance Update" as a regular item on PMC meeting agendas; a balance sheet, income statement and cash flow statements can be provided, at least quarterly.

In response to questions raised, the following comments were offered:

- MN-S staff monitor the internal controls of the MN-S; an external contractor has been retained to ensure the Region's audits occur simultaneously
- The MN-S is obliged to report back on how funding the MN-S receives has been administered; similarly, Regions report back to the MN-S and Locals report back to their respective Region
- Operational budgets could be prepared prior to fiscal year-end, for approval by the Regional Councils, to help guide how funding received will be administered
- Some emergency COVID-19 supports may still be available upon request, for families in need (e.g. personal protective equipment, food hampers, accommodations for isolation)
- A report is being prepared on how the MN-S' COVID-19 Relief Funding was utilized.

It was MOVED (Leonard Montgrand) and SECONDED (Kathie Pruden Nansel)

That the Métis Nation – Saskatchewan Provincial Métis Council (PMC) accept the "Finance Update" presented to the PMC on September 21, 2021.

9. PROVINCIAL MÉTIS YOUTH COUNCIL (PMYC) ELECTION

During discussion on the November 5 and 6, 2021 PMYC Election, comments were offered on:

- References in the *Constitution of the Métis Nation Saskatchewan* to the inclusion of a PMYC representative on the PMC
- The PMC's July 20, 2021 approval of funding (Resolution #210720-07) for the PMYC election:
 - Youth engagement and the allocation of resources could be considered post-election
 - o A Communications Strategy could help encourage youth involvement in the election.

It was MOVED (Robert LaFontaine) and SECONDED (Kathie Pruden Nansel)

That the Métis Nation – Saskatchewan Provincial Métis Council directs that the Provincial Métis Youth Council (PMYC) election be postponed (possibly to early in 2022), and in the interim that:

- A Youth Advisory Committee (led by the Minister of Youth) be established to engage with youth in all regions; and
- A communications strategy be prepared to encourage youth engagement and participation in the 2022 PMYC Council election.

11. OTHER BUSINESS

11.1 Health and COVID-19 Updates

Marg Friesen, Minister of Health, provided a "Health Update" and commented on:

- The MN-S' COVID-19 Vaccine Incentive Draws (the "This Is Your Shot" campaign), which was initiated to encourage Métis citizens to get vaccinated:
 - o Prizes are available to citizens who are fully vaccinated prior to the draw deadlines
 - o To date, over 7,000 citizens have entered the draw
- Ensuring the Ministry of Health is informed of any scheduled gatherings or events.

During discussion, comments were offered on:

- A MN-S staff vaccination policy being prepared for release on September 24, 2021, which will:
 - Require staff to provide proof of vaccination by October 30, 2021, unless a letter from a medical professional confirms they are exempt (additional measures will be in effect)
 - Provide staff with time-off during work hours to get vaccinated
- Potentially adapting the MN-S staff vaccination policy for MN-S elected officials to help to ensure a safe working environment
- The Saskatchewan Health Authority's (SHA) revised Public Health Order, which was based on the severity of the COVID-19 variants and the increased transmission rates.

It was MOVED (Leonard Montgrand) and SECONDED (Lisa McCallum)

That the Métis Nation – Saskatchewan Provincial Métis Council direct that a COVID-19 Task Force be established, with representatives from the Northern, Central and Southern regions.

CARRIED (210921-08)

During discussion, comments were offered on:

- The effectiveness of restrictions and protocols in place at the Batoche Fall Festival, including requiring proof of vaccination and temperature checks (rapid COVID-19 tests were given for anyone with an elevated temperature)
- COVID-19 pandemic travel restrictions, which have delayed progress on some priorities
- Consideration of the legal implications of requiring MN-S staff to be vaccinated
- The Ministry of Health's restrictions on MN-S business travel, which:
 - Intend to minimize the risk of COVID-19 transmission in Métis communities
 - o Are based on the increased rates of active COVID-19 cases reported by the SHA.

Request for Action (RFA-210921-02)

It was requested that the COVID-19 Task Force (to be appointed by the Minister of Health in accordance with Resolution #210921-08) develop a COVID-19 Vaccination Policy for the Provincial Métis Council's consideration, that is:

- Applicable to both MN-S staff and elected officials; and
- In effect prior to the Métis Nation Legislative Assembly in November 2021.

11.2 Métis National Council (MNC) – Election and Assembly

Vice President LeClair requested that PMC members meet on the evening of September 28, 2021, prior to the MNC Assembly and Election on September 29-30, 2021.

During discussion, comments were offered on:

- The SHA's new COVID-19 restrictions, which will require all attendees to wear masks
- Ensuring PMC members have the option to attend by videoconference
- Clarifying with MNC staff, that the MNC will arrange to:
 - o Require all attendees to provide proof of vaccination
 - o Provide temperature checks and rapid testing to keep all attendees safe.

11.3 Batoche Fall Festival

Sherry McLennan, Minister of Culture and Heritage, extended appreciation to those who helped support the success of the Batoche Fall Festival.

11.4 Métis Women of Saskatchewan - Elections

Consideration of this item was postponed.

12. CONCLUSION AND CLOSING PRAYER

The meeting concluded with a Closing Prayer offered by Elder Fleury.

Marg Friesen, Minister of Health, reviewed the "COVID-19 Protocols for the Fall 2021 Métis Nation Legislative Assembly" and the proposed safety measures.

During discussion, comments were offered on:

- Measures to ensure the safety of MN-S staff, government, and citizens attending in-person
- Recognition from the Saskatchewan Health Authority (SHA) and the Ministry of Health, regarding the MN-S' enhanced safety measures and protocols
- The feasibility of expanding the proposed "COVID-19 Protocols for the Fall 2021 Métis Nation Legislative Assembly" to apply to all MN-S meetings
- The recent decision to close the MN-S office for the protection and safety of staff
- Potentially creating a HR policy, requiring MN-S employees to be vaccinated.

It was MOVED (Marg Friesen) and SECONDED (Laura Burnoff)

WHEREAS the Métis Nation-Saskatchewan (MN-S) has been a leader in COVID-19 supports and safety procedures, protecting Métis Elders, children, immune-compromised people and other citizens;

WHEREAS the Métis Nation Legislative Assembly (MNLA) brings together delegates from all parts of Saskatchewan and could endanger the health of Métis delegates and communities without strong COVID-19 protocols; and

WHEREAS the MN-S now has the technological ability for delegates to participate fully without being present;

NOW THEREFORE BE IT RESOLVED that the Provincial Métis Council support the following COVID-19 protocols for the Fall 2021 MNLA:

- 1. In-Person and Virtual Attendance:
 - a) In-person attendance: In-person attendance at the MNLA will be available to delegates, designated staff and invited attendees who have received two COVID-19 vaccinations.
 - b) Virtual Attendance: Delegates who are unvaccinated for COVID-19 (either by choice or for other reasons), delegates who have received one dose of vaccination, and delegates who are concerned about the safety of in-person gatherings, can participate in the MNLA online via the Zoom platform. Delegates who participate by Zoom will still be able to vote, participate in roll call, and speak to resolutions.
- 2. Screening:
 - a) All delegates, designated staff and invited attendees who are eligible for in-person attendance will be required to show proof of vaccination (either QR code or paper vaccination record) at the entrance to the MNLA. After this, they will receive a bracelet as proof of vaccination.
 - b) Screening will be done daily and will include:
 - Answering questions on COVID-19 symptoms; and
 - Temperature checks.

Anyone who has an elevated temperature or shows evidence of COVID-19 symptoms will not be allowed to enter the MNLA. Arrangements will be made for them to participate by Zoom. Additionally, MN-S health officials will follow up with them on their health status.

- c) Rapid testing will be provided on-site to accommodate the following circumstances:
 - Eligible participants who are not able to provide proof of vaccination
 - Eligible participants who have been in close contact with a positive case of COVID-19 within the past 14 days
 - Any delegates, designated staff or invited attendees who would like to be tested.

Anyone who tests positive will not be allowed to enter the MNLA. Arrangements will be made for them to participate by Zoom. Additionally, MN-S health officials will follow up with them on their health status.

- d) Individuals who refuse to meet any of these screening requirements will not be allowed to enter.
- 3. Safety Protocols at Venue:
 - a) Masks will be required except when eating or drinking;
 - b) Social distancing should be observed as much as possible; and
 - c) Hand sanitizing.
- 4. Observers, Family and Others:
 - a) In-person attendance at the MNLA will be restricted to eligible delegates, designated staff and invited attendees. This applies to all MNLA events, including meetings, banquets and other meals.
 - b) All others are invited to watch the livestream of the MNLA via the MN-S website.

NOW THEREFORE BE IT FURTHER RESOLVED that the protocols outlined above be accepted as COVID-19 Safety Protocol Measures, and adapted accordingly for all future MN-S gatherings and meetings.

- Ongoing supports available for Métis patients through the MN-S Cancer and Dialysis Transportation Program
- Significant interest in the Mental Health Program; Mental Health Navigators are supporting clients and connecting them to other mental health providers as needed
- Rapid testing kits used as part of the safety protocols implemented at Batoche
- Over 10,000 entries received to-date for the MN-S COVID-19 Vaccine Incentive Draw, which prompted significant vaccination uptake in some areas
- The SHA's ability to set-up Métis-specific vaccine clinics.

Minister Friesen provided additional comments on:

- Ensuring that patients travelling for cancer and dialysis treatment appointments during the pandemic are served by the programs intended to support them
- Ongoing collaboration with the SHA in responding to the needs of citizens.

During discussion, appreciation was extended to the elected officials for their continued support of the Ministry of Health's efforts to keep communities and citizens safe.

9.2 Audit and COVID-19 Funding Update

Marg Friesen, Minister of Finance, reviewed the funding regions received through COVID-19 Emergency Funding or the Meadow Lake Tribal Council (MLTC).

During discussion, comments and clarifications were offered on:

- Releasing funding to regions, after Regional Councils have reviewed and approved their region's quarterly expense reports and annual audited financial statements
- A manual being prepared for regions by the MN-S Finance Department, which includes report templates and a schedule of when regional reports are due
- Training on the new bookkeeping system to support consistent regional reporting processes
- The distribution of regional funding, based on the population of Métis citizens, and emerging situations and events.

Health Break

The meeting recessed at 12:25 p.m. and reconvened at 1:00 p.m. As Vice President LeClair was absent when the meeting resumed, President McCallum assumed the Chair.

10.4 Provincial Secretary - Update

Secretary McCallum requested that the upcoming MN-S Retreat consider the Provincial Secretary's Workplan, and expressed concerns related to some false allegations that she was supporting citizenship in another Governing Member's registry.

Sherry McLennan, Minister of Heritage, welcomed discussion at the upcoming MN-S Retreat on how the MN-S will be acknowledging Louis Riel Day.

10.2 Update on the Provincial Métis Youth Council (PMYC) Election

Dorothy Myo, Senior Director of Policy and Research, provided an update on the online election for the PMYC President, scheduled November 5-6, 2021 and noted that:

- Nominations opened October 16, 2021 and will close October 21, 2021, at 5:00 p.m.
- Orientation sessions were held for youth on the responsibilities of the President's role
- An October 25, 2021 "All Candidates Virtual Forum", will be hosted by Eagle Feather News.

Gwen LaFond, Chief Electoral Officer, provided additional comments on:

- Candidates nominated for the position of PMYC President, posted at https://mnselection.ca/
- The importance of PMC members remaining non-partisan with respect to the election, and not supporting, promoting or funding any PMYC candidates' campaigns
- Election guidelines provided to the PMC outlining standards for a fair election process.

10.3 Email Communications

In response to a question, it was confirmed that PMC members could request that emails sent to their MN-S email addresses be re-directed to their personal email addresses.

BE IT FURTHER RESOLVED that subject to the aforementioned condition, members of the PMC do hereby approve of the following compensation structure for PMC members holding ministerial portfolios:

- A. Except for the Vice-President and the President of the MN-S, members of the PMC with ministerial responsibilities shall be compensated \$151,921.00 annually, representing a \$51,253.00 increase from their current annual rate of compensation;
- B. The Vice-President shall be compensated \$184,867.00, representing a \$25,626.00 increase from their current annual rate of compensation; and
- C. The President shall be compensated \$199,511.00 annually, representing a \$25,626.00 increase from their current annual rate of compensation.

- Budgeting for the financial impacts of the MWS election processes; the final cost of the PMYC elections will be reviewed before the cost for the MWS election can be estimated
- Funding allocated to the LFDM to maintain an office and two staff members.

It was requested that the President, Les Filles de Madeleine (LFDM), provide for review at the next Provincial Métis Council (PMC) Meeting, an update report that includes the following:

- Budget documents indicating how funds allocated to the LFDM have been utilized (including funding previously provided to the LFDM to support the September 2021 election);
- Clarification on the role of the LFDM and its relationship with the PMC;
- Further information on the upcoming election process, including the proposed election date;
- The LFDM Constitution and Bylaws document; and
- The Minutes of the April 10, 2021, LFDM Secretariat Inc. Board of Directors (referenced at the August 17, 2021, PMC Meeting).

13.3 Provincial Secretary's Workplan

- A suggestion to consider developing a Local Act or Local Constitution, potentially as part of the Constitutional Reform process
- Education and outreach activities proposed to support citizen's involvement in Locals
- Clarification needed on some of the activities referenced in the Workplan, which may overlap with the roles and activities of Legislative Services and other processes
- The proposed budget to support the Workplan, which has not been approved
- The importance of PMC Executives (and other PMC members) consulting with Regional Directors prior to attending meetings in their respective regions; an invitation needs to be extended to Regional Directors to participate in those meetings.

Secretary McCallum confirmed that she would seek further consideration of the Workplan with MN-S staff and the Vice President, and would work towards drafting a three-month plan that could potentially coincide with the MN-S' Constitutional Reform process.

13.7 Reaching Home Funding - Support from the PMC

Regional Director McLennan reported that an application was submitted for Reaching Home Funding to support two safe houses, which prompted a request for a letter of support from the PMC.

During discussion, Regional Director McLennan agreed to communicate directly with the Chief Executive Officer and the Minister of Housing and Infrastructure, regarding this matter.

NOW THEREFORE BE IT RESOLVED that:

- 1. The MN-S Inc., in its capacity as sole member of the PMHC, hereby approves a special resolution authorizing and directing the dissolution of the PMHC pursuant to the provisions of the NPCA;
- 2. WHEREAS the establishment of a Métis Research Chair and Institute for Métis Governance and Policy at the Johnson Shoyama Graduate School of Public Policy (JSGS) builds upon and supports the important work done to date through the existing Memorandum of Understanding with the University of Saskatchewan;

NOW THEREFORE BE IT RESOLVED that the MN-S provide a four-year commitment of \$172,500 per year to start in the 2022-23 fiscal year, to support the establishment of a Métis Research Chair and Institute for Métis Governance and Policy at the JSGS.

8.4 Provincial Secretary's Role

Lisa McCallum, Provincial Secretary, requested discussion on:

- A travel expense claim submitted by the Provincial Secretary, which was not accepted
- The feasibility of a salary increase for the Provincial Secretary's role.

During discussion, comments were offered on:

- The PMC's prior review of the Provincial Secretary's workplan, which was not approved
- The MN-S Travel Policy approved by the PMC on August 17, 2021, which did not include a travel budget for the Provincial Secretary
- Previous PMC resolutions and requests that PMC Executive Members notify Regional Directors when they are coming into their region to discuss MN-S business
- Feedback anticipated at the upcoming community consultation sessions on the role and duties of the Provincial Secretary.

Request for Action (RFA-220310-07)

President McCallum requested information on:

- Previous PMC resolutions or requests, reminding Executive Members to notify Regional Directors when they are coming into their region to discuss MN-S business; and
- The MN-S Travel Policy approved by the PMC, which did not provide a travel budget specifically for the Provincial Secretary.

MEETING ADJOURNED

The MN-S PMC Meeting held March 10-11, 2022, adjourned on March 10, 2022, at approximately 6:00 p.m. after agreeing to reconvene at 9:00 a.m. on March 11, 2022.

MEETING RECONVENED

The MN-S PMC Meeting held March 10-11, 2022, reconvened on March 11, 2022, at 9:10 a.m. It was confirmed that the meeting was being live-streamed.

CALL TO ORDER AND OPENING PRAYERS

President McCallum confirmed that quorum was present before calling the meeting back to order at approximately 9:15 a.m. Elders Norman Fleury and Deborah Smith offered Opening Prayers.

6. OPENING REMARKS FROM THE PRESIDENT

President McCallum reviewed the MN-S' ongoing efforts to maintain relationships with other governments. He recalled the Oath of Office each PMC member agreed to, which recognized the rich history of the Métis people and the courage and dedication of their ancestors.

Additional comments were offered on:

- Recent changes to the COVID-19 pandemic restrictions in Saskatchewan which would soon enable Grand Entry processions and other traditions to resume at MN-S events
- The PMC Retreat held prior to the March 10-11, 2022 PMC Meeting, which provided an opportunity to discuss governance issues and other priorities.

9.1 Resumption of Constitutional Reform Consultations

Michelle LeClair, Vice President, and Dorothy Myo, Senior Director of Policy and Research, referred to the information provided, and commented on:

- The proposal to resume the Constitutional Reform Consultations in April 2022
- Collaborating with Regional Directors to schedule 1.5 days in each community, to provide evening sessions for people who work during the day, daytime sessions for Elders, and virtual sessions for citizens who are unable to attend in person
- Seven different "bundles" of inter-related topics to be considered at the sessions
- Plans to review the feedback before the next series of consultations in the fall of 2022.

During discussion, comments were offered on:

- Involving regional facilitators who understand the community's unique needs to help coordinate the consultations (e.g. scheduling around seeding/harvesting seasons, accommodating language needs, arranging for written feedback, etc.)
- Potentially inviting local radio stations to broadcast consultations for citizens to listen to.

It was MOVED (Michelle LeClair) and SECONDED (Kathie Pruden Nansel)

WHEREAS delegates at the April 2019 Métis Nation Legislative Assembly (MNLA) directed the Métis Nation - Saskatchewan (MN-S) to conduct a constitutional reform process under Resolution #MNLA190414-11;

WHEREAS in 2020, the MN-S halted the constitutional reform process due to concerns arising from the COVID-19 pandemic;

WHEREAS it is essential that the transition from a not-for-profit to a self-governance model is based on consultations with Métis communities and the real needs of Métis citizens; and

WHEREAS the Finance Committee has reviewed a budget of \$1,938,000 for the resumption of constitutional reform engagements, as presented in the report titled, "Voice of the People: Continuing our Constitutional Reform Journey" for the 2022 fiscal year;

NOW THEREFORE BE IT RESOLVED that the Provincial Métis Council approves the "Voice of the People: Continuing our Constitutional Journey" plan, work plan and budget of \$1,938,000 as the model for resuming the constitutional reform process, beginning in April 2022.

9.2 Declaration of Employment

Autumn LaRose-Smith, President, Provincial Métis Youth Council, noted that although the November 15, 2021 Resolution #211115-10 confirmed that PMC members (with portfolios or Ministerial roles) would not hold outside employment, it did not specify a deadline.

During discussion, comments were offered on:

- Requiring PMC members who are portfolio holders and/or act in a ministerial role to notify the President in writing by March 31, 2022, that they do not hold outside employment
- An update anticipated by the next PMC meeting, confirming the status of PMC members who are portfolio holders and/or act in a ministerial role.

It was MOVED (Autumn LaRose-Smith) and SECONDED (Wendy Gervais)

WHEREAS the Provincial Métis Council (PMC) passed Resolution #211115-10 on November 15, 2021, directing that PMC members "...who accept portfolios and who assume associated ministerial responsibilities are expected to devote themselves entirely to the pursuits of the MN-S and are prohibited from holding outside employment";

WHEREAS the PMC members who are portfolio holders or who assume associated ministerial responsibilities have received ministerial financial compensation effective November 15, 2021; and

WHEREAS there was no fixed date attached to Resolution #211115-10 regarding confirmation of end dates of outside employment;

NOW THEREFORE BE IT RESOLVED that on or before March 31, 2022, all PMC members who are portfolio holders and/or act in a ministerial role are to confirm in writing to the President of the Métis Nation-Saskatchewan, that they hold no outside employment, contracts, or any other employment obligations that would contravene the spirit and intent of the PMC's November 15, 2021 Resolution #211115-10; and

BE IT FURTHER RESOLVED that a report be provided on the status of PMC members who are portfolio holders and/or act in a ministerial role on or before the April 19, 2022 PMC meeting.

9.3 Early Learning Child Care

9.3.1 Extending the Michif and Dene Early Learning Pilot Project

Related information (provided with the agenda):

- Briefing Note on the "Michif and Dene Early Learning Language Programming"

Lisa Fleming, Director, Early Learning and Child Care / Child and Family Services, referred to the information provided and commented on the proposal to expand the Michif and Dene Early Learning Project to increase enrollment to up to 400 children from all regions.

During discussion, comments were offered on:

- Discussions with school divisions to identify schools for the program based on their size, space, location, and other factors
- Efforts to initially establish at least one program in each region
- Consultations needed on early learning programs to ensure that the language and dialects being taught reflect the community's needs.

It was MOVED (Tim Roussin) and SECONDED (Loretta King)

WHEREAS the future of Michif and Dene languages will be strengthened with early language programming in a high-quality learning environment;

WHEREAS the Métis Nation - Saskatchewan (MN-S) currently supports Michif and Dene early learning programming in nine school divisions for more than 230 Métis children and their families;

WHEREAS expanding this project to the remaining six additional MN-S Regions will provide more Métis children with an opportunity to learn their language and Métis identity;

WHEREAS the Ministry of Early Learning and Child Care has recommended to the Provincial Métis Council (PMC) at this meeting of March 10-11, 2022, that the Michif and Dene Early Learning Pilot Project be extended for the school years of 2022-23 and 2023-24; and

WHEREAS the Ministry of Early Learning and Child Care has further recommended that the Michif and Dene Early Learning Pilot Project be expanded to include six additional MN-S Regions at this meeting of March 10-11, 2022;

NOW THEREFORE BE IT RESOLVED that the MN-S PMC approves the extension of the Michif and Dene Early Learning Pilot Project for the school years of 2022-23 and 2023-24 in accordance with the following funding allocations, as proposed at this meeting of March 10-11, 2022:

- a) \$2,600,000 for the 2022-23 school year; and
- b) \$2,250,000 for the 2023-24 school year;

BE IT FURTHER RESOLVED that the PMC approves the expansion of the Michif and Dene Early Learning Pilot Project to include schools within Northern Region 1, Eastern Region 1, Eastern Region 2, Eastern Region 2A, Eastern Region 3 and Western Region 1A; and

BE IT FURTHER RESOLVED that the PMC authorizes the Ministry of Early Learning and Child Care to establish partnership agreements with the school divisions within each of the designated MN-S Regions as part of the project.

- Including representatives from multiple MN-S ministries on the selection committee being established to review the funding applications
- The program's intent to support children under eight years of age; requests for children over eight years of age could be considered.

Request for Action (RFA-220311-01)

It was requested that clarification be provided at the next Provincial Métis Council Meeting on whether Métis children have access to funding intended for First Nations children through Jordan's Principle.

It was MOVED (Tim Roussin) and SECONDED (Loretta King)

WHEREAS Métis children who are impacted by complex medical, academic and behavioural needs may require additional supports;

WHEREAS supporting medically fragile and developmentally complex children may present undue financial hardships for Métis families;

WHEREAS financial assistance in the form of an annual Métis Children Accessibility Grants Program will allow Métis children and families to access supports and programs that may enhance the quality of life experiences;

WHEREAS the Métis Nation – Saskatchewan (MN-S) Métis Children Accessibility Grants Program will assist qualified Métis families with up to \$5,000 annually to support a documented diagnosis requiring financial support, in order for the qualified Métis child and family to access the requested needs and services;

WHEREAS the Ministry of Early Learning and Child Care will establish a selection committee to review and approve grant applications based on need, diagnosis, and documentation not to exceed \$5,000 per individual child and \$2,000,000 in the entirety of the 2022-23 fiscal year; and

WHEREAS the Ministry of Early Learning and Child Care has further recommended that the Métis Children Accessibility Grants Program be established at this meeting of March 10-11, 2022;

NOW THEREFORE BE IT RESOLVED that the MN-S Provincial Métis Council approves the Métis Children Accessibility Grants Program at this meeting of March 10-11, 2022.
