7.2 Human Resources Committee – Update (Continued)

It was MOVED (Michelle LeClair) and SECONDED (Autumn LaRose-Smith)

WHEREAS on or about January 26, 2022, a formal written complaint against Sherry McLennan relating to the unauthorized use of a Métis Nation - Saskatchewan (MN-S) vehicle assigned to Western Region 2 (the "Complaint"), has been submitted to the Provincial Métis Council (PMC);

WHEREAS under the Handbook for Executives, Ministers and Members of the Provincial Métis Council (the "Executive Handbook"), written complaints are referred to the Human Resources (HR) Committee and assigned to a third-party investigator to investigate the subject matter of a complaint to determine whether there has been a breach of the Code of Conduct and recommend such corrective action as may be necessary in the circumstances;

WHEREAS it is desirable that certain interim measures be taken to protect the interests of the MN-S pending the outcome of the aforementioned investigation;

NOW THEREFORE BE IT RESOLVED that:

- 1. The PMC shall refer the Complaint to the HR Committee to be referred to a third-party investigator:
 - (a) to investigate into the subject matter of the Complaint; and
 - (b) if the investigator finds there has been a breach of the Code of Conduct, to recommend appropriate remedial measures as may be necessary to resolve the Complaint.
- 2. Pending the outcome of the investigation into the Complaint, Sherry McLennan be placed on paid administrative leave from her PMC duties, including those duties relating to Standing Committees, her Ministerial duties and any such consequential interim measures as may be necessary and in the best interests of the MN-S; and
- 3. The HR Committee shall take all reasonably practicable measures to ensure that the investigation process is completed by the next meeting of the PMC on February 15, 2022.

WHEREAS Article 3.10 of the *Constitution of the Métis Nation – Saskatchewan*]authorizes the Provincial Métis Council (PMC) to set the date and place for each sitting of the Métis Nation Legislative Assembly (MNLA);

NOW THEREFORE BE IT RESOLVED that the 2022 Spring MNLA be held May 13, 14 and 15, 2022, or June 3, 4 and 5, 2022, at Prairieland Park, 503 Ruth Street West, Saskatoon, Saskatchewan, respecting Provincial and Métis Nation – Saskatchewan health protocols and restrictions in effect. During discussion, comments were offered on:

- Revising the Terms of Reference (and "Appendix B") to include: "Meet with the Provincial Métis Youth Council and President to ensure youth voices are represented"
- Preparing a more substantive workplan and budget for the Commissioner for Review of Locals after the position has been filled
- Posting the job description for the Commissioner for Review of Locals on the MN-S website.

It was MOVED (Michelle LeClair) and SECONDED (Lisa McCallum)

WHEREAS the Métis Nation Legislative Assembly (MNLA), at its duly convened meeting on November 27 and 28, 2021, passed a resolution approving the appointment of a Commissioner for Review of Locals (the "Commissioner") to review and report on the status of Locals, both recognized and unrecognized; and

WHEREAS recommendations resulting from the Commissioner for constitutional and other legislative changes will be referred to the Constitutional Reform Process;

NOW THEREFORE BE IT RESOLVED that the Provincial Métis Council at this duly convened meeting of January 26, 2022, hereby approves the proposed Terms of Reference for the Commissioner, with an amendment to include "Meet with the Provincial Métis Youth Council and President to ensure youth voices are represented":

- In "Section 1 Consultations" of the "Terms of Reference for the Commissioner for Review of Locals"; and
- In "Section 2 Consultations" of the "Commissioner for Review of Locals Workplan and Budget 2022 (Appendix B)".

9.3 Early Learning and Child Care Conference

Minister Tim Roussin referred to the information provided and offered additional comments on the MN-S hosting an Early Learning and Child Care (ELCC) Conference on April 28-30, 2022, at the Saskatoon Inn (or virtually if required by Provincial and MN-S health requirements).

Lisa Fleming, Director, ELCC / Child and Family Services, acknowledged:

- The opportunity to bring together educators from across Saskatchewan
- The MN-S' partnership with the University of Saskatchewan's Early Years Program
- Scheduling a "kitchen party" event on the evening of April 29, 2022, with jigging and fiddle programs designed for children's participation.

It was MOVED (Tim Roussin) and SECONDED (Kathie Pruden Nansel)

WHEREAS programming for Métis children will be strengthened with early learning professional development for educators;

WHEREAS the Métis Nation - Saskatchewan (MN-S) values the knowledge and direction of our Elders;

WHEREAS sharing and building resources for our Métis children will provide more Métis children the opportunity to learn their Métis identity, culture, language and traditions; and

WHEREAS the Ministry of Early Learning and Child Care (ELCC) has recommended to the Provincial Métis Council (PMC) at this meeting of January 26, 2022, that an ELCC Conference be held April 28-30, 2022, highlighting Elder knowledge, Métis early learning resources, and the sharing of information for 350 early learning educators from all 12 MN-S regions;

NOW THEREFORE BE IT RESOLVED that the PMC approves funds not to exceed \$500,000 (subject to the approval of the MN-S Finance Committee) for an ELCC Conference to be held April 28-30, 2022, in Saskatoon, Saskatchewan, respecting all Provincial and MN-S health protocols and restrictions in effect.

9.4 Provincial Métis Housing Corporation

Riva Racette, Legal Counsel, reviewed the MNLA's direction that the MN-S initiate formalities to authorize the dissolution of the Provincial Métis Housing Corporation (PMHC) in accordance with the *Non-profit Corporations Act*, *1995* (Saskatchewan).

Christena Konrad, Director of Housing, provided additional comments on the dissolution of the PMHC, which required two resolutions to confirm the PMC's approval and authorization.

It was MOVED (Mervin "Tex" Bouvier) and SECONDED (Laura Burnouf)

WHEREAS the Métis Nation Legislative Assembly (MNLA) has directed the members of the Provincial Métis Council (PMC), in their capacity as directors of the Métis Nation – Saskatchewan Secretariat Inc. ("MN-S Inc.") to approve a resolution authorizing and directing the MN-S Inc., in its capacity as the sole member of the Provincial Métis Housing Corporation (PMHC), a corporation incorporated under the *Non-profit Corporations Act, 1995* (Saskatchewan) (*NPCA*), to approve a special resolution authorizing and directing the dissolution of the PMHC, pursuant to the provisions of the *NPCA*;

NOW THEREFORE BE IT RESOLVED that:

- 1. The MN-S Inc., in its capacity as sole member of the PMHC, hereby approves a special resolution authorizing and directing the dissolution of the PMHC pursuant to the provisions of the *NPCA*;
- 2. Any one director of the MN-S Inc. is hereby authorized and directed to execute and deliver on behalf of the MN-S Inc. a written special resolution of the sole member of PMHC, pursuant to section 132 of the *NPCA*, proposing the dissolution of PMHC pursuant to the provisions of the *NPCA* in such form as such director so executing and delivering shall approve;
- 3. Any one director of the MN-S Inc. is hereby authorized and directed to execute and deliver on behalf of the MN-S Inc. any other agreements, instruments, directions or other documents as may be necessary or desirable to effect the intent of this resolution; and
- 4. The dissolution as aforesaid shall be administered with the support of administration and such advisors, as are necessary to ensure compliance with all legal requirements.

WHEREAS the Métis Nation – Saskatchewan Secretariat Inc., being the sole member of the Provincial Métis Housing Corporation (the "Corporation"), has determined to approve a special resolution authorizing and directing the dissolution of the Corporation in accordance with the provisions of the *Non-profit Corporations Act, 1995 (Saskatchewan) (NPCA)*.

NOW THEREFORE BE IT RESOLVED as a Special Resolution that:

- 1. The dissolution of the Corporation pursuant to section 192(3) of the NPCA is hereby approved;
- 2. Pursuant to section 192(3)(a) of the NPCA, the directors of the Corporation are hereby authorized and directed to cause the Corporation to distribute all property and discharge all obligations of the Corporation in the manner contemplated by the NPCA and the articles of the amalgamation of the Corporation;
- 3. Upon completion of the procedures contemplated by section 192(3)(b) of the NPCA, the directors of the Corporation are hereby authorized and directed to send articles of dissolution to the director (as such term is defined in the NPCA) as contemplated by section 192(5) of the NPCA; and
- 4. The directors of the Corporation are hereby authorized and directed to execute and deliver on behalf of the Corporation any agreements, instruments, directions or other documents as may be necessary or desirable to effect the intent of this special resolution.

9.6 Building Knowledge and Professional Capacity

Kurtis Boyer, Faculty Educator, Johnson Shoyama Graduate School of Public Policy, University of Saskatchewan (USask), referred to the information provided and offered comments on:

- The proposed program, which reflected on the Memorandum of Understanding signed by the MN-S and USask
- Ensuring there is capacity for young Métis people to lead and serve as future decision-makers
- Offering a culturally-safe course where Métis students can learn about their government.

3:40 p.m.

Vice President LeClair rejoined the meeting.

During discussion, comments were offered regarding:

- The intent to hire a Métis Research Chair position at the USask, in accordance with USask's hiring processes
- An opportunity to complement the existing research community of Métis scholars at USask:
 - Governance principles and a framework for Indigenous research have been developed by the MN-S Ministry of Health and USask
 - The Métis Research Chair will have a direct relationship with MN-S and USask, which could support some unique research topics.

It was MOVED (Michelle LeClair) and SECONDED (Leonard Montgrand)

WHEREAS the Métis Nation – Saskatchewan (MN-S) continues its transition from a not-for-profit model to self-government;

WHEREAS it is essential that this transition allow the Métis of Saskatchewan to establish a government grounded in Métis traditions, culture and practices and the exploration of meaningful ways in which these traditions and practices should inform the evolution of our Métis government;

WHEREAS the MN-S seeks to support the creation of a strong Métis-led space in which this work can be supported and in which Métis students with an interest in this area can participate and be supported to work with Métis leaders, communities and our Métis government; and

WHEREAS the establishment of a Métis Research Chair and Institute for Métis Governance and Policy at the Johnson Shoyama Graduate School of Public Policy (JSGS) builds upon and supports the important work done to date through the existing Memorandum of Understanding with the University of Saskatchewan;

NOW THEREFORE BE IT RESOLVED that the MN-S provide a four-year commitment of \$172,500 per year to start in the 2022-23 fiscal year, to support the establishment of a Métis Research Chair and Institute for Métis Governance and Policy at the JSGS.

10. RESIGNATION OF THE MN-S TREASURER

Richard Quintal, Chief Executive Officer, acknowledged the December 21, 2021 letter of resignation received from Robert Lafontaine (effective December 31, 2021), which President McCallum accepted in writing on December 22, 2021.

During discussion, comments were offered regarding:

- The *Saskatchewan Métis Elections Act 2007,* which does not require a by-election to be called to fill the vacant position, at this time
- Recognizing that the role of Treasurer may no longer be required as the MN-S' structure transitions from a not-for-profit organization to self-government.

11. FINANCE REPORT - THIRD QUARTER FINANCIAL REPORT PRESENTATION

Marg Friesen, Minister of Finance, referenced the PMC's November 15, 2021 direction (in Resolution #211115-11), which authorized the establishment of parameters and guidelines for travel of elected officials and holding in-person meetings. She confirmed that related policies and templates were being prepared for the PMC's consideration at the next PMC meeting.

In response to a query, it was confirmed that the breakdown of professional fees, legal fees, etc., requested during the MNLA, was provided to, and reviewed with the PMC prior to the MNLA.

It was MOVED (Marg Friesen) and SECONDED (Loretta King)

That the Métis Nation – Saskatchewan Provincial Métis Council (PMC) table the "Finance Report – Third Quarter Financial Report Presentation" to the February 15, 2022 PMC meeting.

Request for Action (RFA-220126-01)

It was requested that "Finance Report" be included as a standing item on future Provincial Métis Council meeting agendas, near the beginning of the agenda to provide time for consideration of financial matters.

12. OTHER BUSINESS

12.1 MN-S Registry

Discussion ensued on the feasibility of providing Regional Directors with a list of citizens within their respective regions.

It was MOVED (Leonard Montgrand) and SECONDED (Lisa McCallum)

That the Métis Nation – Saskatchewan (MN-S) Provincial Métis Council directs that MN-S staff and Legal Counsel consider options for providing Regional Directors access to a list of Métis citizens in their respective regions, after relevant privacy legislation and potential legal implications have been duly considered.

12.2 COVID-19 Health Directive

Marg Friesen, Minister of Health, confirmed that PMC members had been encouraged to follow the Saskatchewan Health Authority's guidelines and restrictions and refrain from in-person meetings and non-essential travel.

8.1 Business Arising from the Minutes (Continued)

In response to a query, Tammy Mah, Les Filles de Madeleine (LFDM), confirmed that the following information items requested at the November 15, 2021 PMC meeting would be provided at the February 15, 2022 PMC meeting (as indicated in Request for Action #RFA-211115-01):

- Budget documents indicating how funds allocated to the LFDM have been utilized (including funding previously provided to the LFDM to support the September 2021 election);
- Clarification on the role of the LFDM and its relationship with the PMC;
- Further information on the upcoming election process, including the proposed election date;
- The LFDM Constitution and Bylaws document; and
- The Minutes of the April 10, 2021, LFDM Secretariat Inc. Board of Directors (referenced at the August 17, 2021, PMC Meeting).

12.3 Setting a Deadline for PMC Portfolio Holders to Cease Outside Employment

Discussion ensued on the resolution passed by the PMC on November 15, 2021, directing that PMC portfolio holders no longer hold outside employment.

Due to time constraints, it was agreed that this matter be considered at the February 15, 2022 PMC meeting.

13. CONCLUSION AND CLOSING PRAYER

- Plans to review the feedback before the next series of consultations in the fall of 2022.

During discussion, comments were offered on:

- Involving regional facilitators who understand the community's unique needs to help coordinate the consultations (e.g. scheduling around seeding/harvesting seasons, accommodating language needs, arranging for written feedback, etc.)
- Potentially inviting local radio stations to broadcast consultations for citizens to listen to.

WHEREAS delegates at the April 2019 Métis Nation Legislative Assembly (MNLA) directed the Métis Nation - Saskatchewan (MN-S) to conduct a constitutional reform process under Resolution #MNLA190414-11;

WHEREAS in 2020, the MN-S halted the constitutional reform process due to concerns arising from the COVID-19 pandemic;

WHEREAS it is essential that the transition from a not-for-profit to a self-governance model is based on consultations with Métis communities and the real needs of Métis citizens; and

WHEREAS the Finance Committee has reviewed a budget of \$1,938,000 for the resumption of constitutional reform engagements, as presented in the report titled, "Voice of the People: Continuing our Constitutional Reform Journey" for the 2022 fiscal year;

NOW THEREFORE BE IT RESOLVED that the Provincial Métis Council approves the "Voice of the People: Continuing our Constitutional Journey" plan, work plan and budget of \$1,938,000 as the model for resuming the constitutional reform process, beginning in April 2022.

WHEREAS the PMC members who are portfolio holders or who assume associated ministerial responsibilities have received ministerial financial compensation effective November 15, 2021; and

WHEREAS there was no fixed date attached to Resolution #211115-10 regarding confirmation of end dates of outside employment;

9.3.1 Extending the Michif and Dene Early Learning Pilot Project

Lisa Fleming, Director, Early Learning and Child Care / Child and Family Services, referred to the information provided and commented on the proposal to expand the Michif and Dene Early Learning Project to increase enrollment to up to 400 children from all regions.

During discussion, comments were offered on:

- Discussions with school divisions to identify schools for the program based on their size, space, location, and other factors
- Efforts to initially establish at least one program in each region
- Consultations needed on early learning programs to ensure that the language and dialects being taught reflect the community's needs.

WHEREAS the future of Michif and Dene languages will be strengthened with early language programming in a high-quality learning environment;

WHEREAS the Métis Nation - Saskatchewan (MN-S) currently supports Michif and Dene early learning programming in nine school divisions for more than 230 Métis children and their families;

WHEREAS expanding this project to the remaining six additional MN-S Regions will provide more Métis children with an opportunity to learn their language and Métis identity;

WHEREAS the Ministry of Early Learning and Child Care has recommended to the Provincial Métis Council (PMC) at this meeting of March 10-11, 2022, that the Michif and Dene Early Learning Pilot Project be extended for the school years of 2022-23 and 2023-24; and

WHEREAS the Ministry of Early Learning and Child Care has further recommended that the Michif and Dene Early Learning Pilot Project be expanded to include six additional MN-S Regions at this meeting of March 10-11, 2022;

NOW THEREFORE BE IT RESOLVED that the MN-S PMC approves the extension of the Michif and Dene Early Learning Pilot Project for the school years of 2022-23 and 2023-24 in accordance with the following funding allocations, as proposed at this meeting of March 10-11, 2022:

- a) \$2,600,000 for the 2022-23 school year; and
- b) \$2,250,000 for the 2023-24 school year;

BE IT FURTHER RESOLVED that the PMC approves the expansion of the Michif and Dene Early Learning Pilot Project to include schools within Northern Region 1, Eastern Region 1, Eastern Region 2, Eastern Region 2A, Eastern Region 3 and Western Region 1A; and

BE IT FURTHER RESOLVED that the PMC authorizes the Ministry of Early Learning and Child Care to establish partnership agreements with the school divisions within each of the designated MN-S Regions as part of the project.

8.3 Emergency Home Repair Program - Eligibility Amendment

 - o Whether having homeowner's insurance is included in the eligibility criteria

- The previous MNLA requested that future Dialogue Forums include a basic "Financial Workshop" to explain how to read the audited financial statements and other schedules being presented for consideration at the MNLA:
 - Sufficient time was required for the "Financial Workshop", which could not be accommodated within a one-hour Dialogue Forum
 - A virtual "Finance Workshop" would be arranged in advance of the MNLA, which all MNLA delegates could access electronically
- Further information on the Dialogue Forums will be provided.

- Queries raised during the last MNLA on items referenced in the financial statements, which were answered at the subsequent PMC meeting
- Structuring the Finance Workshop to provide basic information on revenue streams, expense lines etc., included in the MN-S' financial statements.

NOW THEREFORE BE IT RESOLVED that the PMC hereby supports the recommendations as presented by the HR Committee in its report dated May 27, 2022, and further directs that the recommendations be implemented as follows:

- A. That within 30 days of the date of this Resolution, the Respondent formally apologizes to the PMC in writing:
 - (i) For compromising relationships with other governments, stakeholders and Métis citizens;
 - (ii) For the reputational damage sustained by the MN-S government as a result of the Respondent's actions;
 - (iii) As part of the aforementioned apology, the Respondent make a formal written commitment to rebuild the trust and confidence of her fellow members of the PMC;

- B. Effective immediately, that the Respondent be prohibited from personally renting any further rental vehicles at the MN-S' expense or through any MN-S account;
- C. Recommend to the President to consider the Respondent's immediate removal from portfolio and standing committee(s);
- D. That the PMC work with appropriate technicians to develop protocols and/or policies governing elected officials on subject matters, including:
 - (i) Under what circumstances MN-S' property can be used;
 - (ii) How the MN-S branding should be used, and for what purposes;
 - (iii) How the Métis flag should be used by elected officials as representatives of the MN-S government (protocols related to the Métis flag will be developed in consultation with the Métis Elders Council and the Métis Veterans Council); and
 - (iv) That an update on the status of protocols and/or policies be provided within 90 days of the date of this resolution.

WHEREAS the Lii Bufloo Program will continue to build lifelong love of pride in Métis culture; and

WHEREAS the Ministry of ELCC has recommended to the PMC at this meeting of June 28, 2022, to support the creation and acquisition of Métis early learning resources and the development and implementation of the Lii Bufloo Program for over 2,000 Métis children throughout all 12 MN-S Regions;

NOW THEREFORE BE IT RESOLVED that the MN-S PMC approves funds not to exceed \$1,500,000 annually for the Lii Bufloo Program.

WHEREAS the MN-S seeks to ensure that the unique perspectives and needs of Métis youth are reflected in government decisions, policy and programming, which is stated in the Minister of Youth's mandate letter;

WHEREAS there is a need for a transparent, consistent, fair, accessible and merit-based system to select youth representatives at the regional level to participate in the Provincial Métis Youth Council (PMYC);

WHEREAS the regional councils that select youth representatives may not be aware of all the eligible youth citizens in their regions if they are not registered members of a Local; and likewise, Métis youth citizens may not be aware of opportunities available to participate in the PMYC;

WHEREAS a public call-out and application process will increase the Métis youth's knowledge of the PMYC and increase youth engagement within the MN-S Government;

NOW THEREFORE BE IT RESOLVED that the PMC approves a publicity and recruitment campaign, to be conducted by the Ministry of Youth during the summer of 2022, to encourage youth to apply to be a member of the PMYC; and that Regional Directors and Regional Councils be encouraged to support and promote this campaign; and

BE IT FURTHER RESOLVED that a list of all applicants, which has been depersonalized of identifying data, be provided to regions to allow them to select the best candidate based on their accomplishments; and that Regional Councils provide the PMYC with the name of the applicant selected as their Regional Youth Representative.

WHEREAS a proposed addition to the budget of \$3,500,000 was presented to the Provincial Métis Council (PMC) on June 28, 2022, and recommended for approval, as follows: an additional \$2,000,000 for the fiscal year 2022/23, and an additional \$1,500,000 for the fiscal year 2023/24;

NOW THEREFORE BE IT RESOLVED that the PMC approves, as presented at this meeting on June 28, 2022, the proposed additional two-year budget of \$3,500,000 in the following allocations:

- a) \$2,000,000 for the fiscal year 2022/23 of program funding; and
- b) \$1,500,000 for the fiscal year 2023/24 of program funding;

8.2 Provincial Métis Housing Corporation (PMHC) Article Change

Riva Farrell Racette, Legal Counsel, explained that in order to complete the dissolution of the PMHC, the Articles of Amalgamation (the "Articles") required amendment to remove the reference to the Lieutenant Governor-in-Council. It was confirmed that amending the Articles would not impact the effect of resolutions passed by the MNLA and PMC directing the dissolution of PMHC.

It was MOVED (Loretta King) and SECONDED (Mervin "Tex" Bouvier)

WHEREAS the Métis Nation Legislative Assembly has authorized and directed the members of the Provincial Métis Council in their capacity as the directors of Métis Nation – Saskatchewan Secretariat Inc. (the "Secretariat") to approve a resolution authorizing and directing the Secretariat in its capacity as the sole member of Provincial Métis Housing Corporation (the "PMHC"), a corporation incorporated under the *Non-profit Corporations Act, 1995 (Saskatchewan)* (the "NPCA"), to approve a special resolution amending the Articles of Amalgamation of the PMHC pursuant to the provisions of the NPCA;

NOW THEREFORE BE IT RESOLVED THAT:

1. The Secretariat, in its capacity as sole member of PMHC, hereby approves a special resolution authorizing and directing the amendment of the Articles of Amalgamation of the PMHC pursuant to the provisions of the NPCA to delete the existing provisions of Article 7 of the Articles of Amalgamation, which read as follows:

"As may be considered advisable for the public good and subject to the approval of any plan of distribution by the Lieutenant Governor-in-Council."

and replace with the following:

"Métis Nation - Saskatchewan Secretariat Inc., a corporation established under The Métis Act (Saskatchewan), being the sole member of the corporation."

- 2. Any one Director of the Secretariat is hereby authorized and directed to execute and deliver on behalf of the Secretariat a written special resolution of the sole member of PMHC pursuant to section 132 of the NPCA as authorized, hereby pursuant to the provisions of the NPCA in such form as such Director so executing and delivering shall approve; and
- 3. Any one Director of the Secretariat is hereby authorized and directed to execute and deliver on behalf of the Secretariat any other agreements, instruments, directions or other documents as may be necessary or desirable to effect the intent of this resolution.

WHEREAS the Métis Nation – Saskatchewan Secretariat Inc. (the "Secretariat"), being the sole member of the Provincial Métis Housing Corporation (the "Corporation"), has determined to approve a special resolution authorizing and directing the amendment of the Articles of Amalgamation of the Corporation in accordance with the provisions of the *Non-profit Corporations Act, 1995 (Saskatchewan)* (the "NPCA");

NOW THEREFORE BE IT RESOLVED THAT:

1. The Articles of Amalgamation of the Corporation are hereby amended by deleting the existing provisions of Article 7 of the Articles of Amalgamation, which read as follows:

"As may be considered advisable for the public good and subject to the approval of any plan of distribution by the Lieutenant Governor-in-Council."

and replacing with the following:

"Métis Nation - Saskatchewan Secretariat Inc., a corporation established under The Métis Act (Saskatchewan), being the sole member of the corporation."

2. The Directors of the Corporation are hereby authorized and directed to execute and deliver on behalf of the Corporation any agreements, instruments, directions or other documents as may be necessary or desirable to effect the intent of this special resolution, including, without restriction, the filing of articles of amendment to reflect the above with the Directors of Corporation as contemplated by the NPCA.

8.4 Emergency Home Repairs Program (ERP)

Loretta King, Minister of Housing and Infrastructure, reviewed the information provided and confirmed that demand for the ERP had exceeded the funding available, and the program was on hold since April 1, 2022. Additional funding was requested to re-open the program on October 1, 2022.

During discussion, comments were offered on:

- Urgent and critical requests for ERP support for Elders, and the need to designate housing dollars to at-risk and vulnerable citizens
- The need to undertake a review of Elders who received ERP funding when the program began
- Efforts to secure additional funding through Canada's Energy Efficiency Program
- Community engagement and the collection of data on at-risk and vulnerable Métis citizens to inform a strategy for the next cycle of the ERP
- The need for trustworthy contractors, and a list of recommended contractors available to homeowners through the Housing Department
- Recognition of the housing challenges in the north
- Potential for the Gabriel Dumont Institute to develop a Housing Inspector course
- Confirmation that individuals cannot access the ERP and the First Time Homebuyers program simultaneously.

President McCallum invited the Minister and Director of Housing to attend upcoming meetings with provincial and federal government representatives to discuss Métis housing needs.

Request for Action (RFA-220920-06)

It was requested that the Acting Housing Director come to Northern Region 3 to speak to Elders about funding opportunities for critical home repairs.

It was MOVED (Loretta King) and SECONDED (Brent Digness)

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language - inclusive of Knowledge Keepers, Elders, Youth and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS the Ministry of Housing works across all MN-S Ministries to create a collaborative process to review new and existing programs;

WHEREAS the demand for the Emergency Repair Program (ERP) has exceeded approved available budget and has been on hold since April 1, 2022;

WHEREAS the program requires an additional \$4 million for applications received before April 1, 2022; and

WHEREAS an additional \$2 million is requested to re-open the ERP on October 11, 2022, until funding is fully expended, and as such, the ERP will be closed to new applications for the remainder of the fiscal year;

NOW THEREFORE BE IT RESOLVED that the MN-S PMC approve additional funding to the ERP to a maximum of \$6 million for the remainder of the 2022-2023 fiscal year:

a. A maximum of \$4 million for existing claims up to April 1, 2022;

b. A maximum of \$2 million for new claims received after October 11, 2022.

WHEREAS the Ministry of Housing and Infrastructure is seeking to plan and host the first twoday Saskatchewan Housing and Homelessness Conference in March 2023, including leaders and experts in the Housing and Homelessness sectors;

NOW THEREFORE BE IT RESOLVED that the MN-S PMC approve up to \$500,000 to host a Saskatchewan Housing and Homelessness Conference in March 2023.

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language - inclusive of Knowledge Keepers, Elders, Youth and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis

Council (PMC);

WHEREAS the Ministry of Youth works across all MN-S Ministries to create a collaborative process to review new and existing programs;

WHEREAS the MN-S seeks to ensure that the unique perspectives and needs of Métis Youth are reflected in government decisions, policy and programming, as reflected in the mandate letter to the Minister of Youth and the resolution approving the selection of the Métis Youth Council at the June 2022 PMC Meeting;

WHEREAS it is stated in the Métis National Council (MNC) Secretariat Inc. Bylaws that the MNC General Assembly shall have the responsibility for the formulation of national policies, and it is important to ensure Youth voices are reflected in these national policies;

WHEREAS the MN-S is responsible for selecting fifteen (15) elected provincial voting delegates to attend the MNC General Assembly, and the method of selection of delegates is to be determined by the MN-S, as stated in the MNC Bylaws; and

WHEREAS the *Constitution of the Métis Nation - Saskatchewan* states that the delegates to the MNC General Assembly shall be the Provincial Métis Council (PMC), and the remainder shall be chosen from amongst the members of the Métis Nation Legislative Assembly (MNLA);

NOW THEREFORE BE IT RESOLVED that the MN-S PMC select the Provincial Métis Youth Council (PMYC) President to be a permanent member of the 15 MN-S voting delegates for all future MNC General Assemblies; and

BE IT FURTHER RESOLVED that the PMYC President be responsible for recommending an alternate to be selected by the PMC, from within the PMC. If there are less than 15 PMC members, the PMYC President will be responsible for suggesting to the MNLA an alternate delegate, to ensure the MN-S will have 15 voting delegates if the PMYC President is unable to vote at or attend a MNC General Assembly.

WHEREAS Article 7 of the *Constitution* sets out the foundational requirements for Locals of the MN-S;

WHEREAS Article 7, Section 5, of the *Constitution* provides that the MNLA "shall adopt rules pertaining to the admission and dissolution of Locals";

WHEREAS no formal rules have been adopted by the MNLA with respect to the admission of Locals;

WHEREAS a number of Locals have elected Presidents but, because they have not been recognized by their respective Regional Councils, have not participated at a MNLA since 2018;

WHEREAS the MNLA has directed the MN-S to hire a Commissioner on the Review of Locals to review, among other things, the criteria for recognition of Locals by Regional Councils and a ratification mission by the MNLA;

NOW THEREFORE BE IT RESOLVED that in 2022-23 while the review of Locals is underway, the Provincial Métis Council (PMC) shall recommend to the MNLA that those Locals which are in compliance with all Constitutional requirements of the MN-S, and have applied for recognition, but have been rejected by their Regional Councils, be permitted to participate at the November 19-20, 2022, MNLA; and

BE IT FURTHER RESOLVED that the PMC recommends to the MNLA that the aforementioned Locals be considered for inclusion as voting members at the MNLA on November 19-20, 2022, until such time that the Commissioner on the Review of Locals has completed their mandate.

Jason Mercredi, Acting Director of Housing, reviewed the information provided, and confirmed

President McCallum commended Minister King and the MN-S Housing and Infrastructure Department for their efforts in re-establishing the ERP and confirmed that the MN-S was in discussions at the federal level for increased resources for housing in northern Saskatchewan.

Request for Action (RFA-221025-02)

It was requested that representatives from the MN-S Housing and Infrastructure Department travel to Northern Regions 1, 2 and 3 to conduct engagement sessions on housing needs in northern Saskatchewan.

It was MOVED (Loretta King) and SECONDED (Marg Friesen)

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language - inclusive of Knowledge Keepers, Elders, Youth and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS the Ministry of Housing works across all MN-S Ministries to create a collaborative process to review new and existing programs;

WHEREAS the demand for the Emergency Repair Program (ERP) reopened on October 11, 2022, with an additional \$2 million for new applications, and the uptake for the program was totally committed within seven days as a result of citizens waiting for the program to reopen with new program funds; and

WHEREAS the Métis Housing Strategy has a budgetary carry-over of funds from the past three fiscal years which can be reallocated to the ERP.

NOW THEREFORE BE IT RESOLVED that the PMC is requested to approve the reallocated funds of \$4 million from the Métis Housing Strategy to the ERP for the remainder of the 2022-2023 fiscal year, to continue making funding available for the emergency housing needs of citizens through an established application process.
