9.1 Approval of the Draft Budget 2024/2025

Related information:

Marg Friesen, Minister of Finance, referenced the information provided and offered additional comments on:

- Cost saving strategies intended to uphold the MN-S' fiscal responsibilities
- Funding allocated for mental health and addictions services, and resources available to continue supporting MN-S citizens for the next five years.

During discussion, comments were offered on capacity funding for Locals, and the importance of implementing programs with funding available to sustain them for multiple years.

It was MOVED (Marg Friesen) and SECONDED (Billy Kennedy)

WHEREAS the Métis Nation – Saskatchewan (MN-S) adheres to established financial standards and accounting policies for all funds received on behalf of Métis citizens of Saskatchewan; and

WHEREAS the MN-S government is committed to delivering on the commitments made to its funding partners and citizens;

THEREFORE BE IT RESOLVED THAT the Provincial Métis Council approves the operating budget for 2024-2025 as presented and recommends it to the Métis Nation Legislative Assembly for ratification.

9.2 Setting the Date for the 2025 MN-S Election

Related information (provided with the agenda): "Resolution on Setting the Date for the 2025 Métis Nation – Saskatchewan Election"

It was MOVED (Glen McCallum) and SECONDED (Marg Friesen)

WHEREAS Article 8.2 of the *Constitution of the Métis Nation – Saskatchewan* requires elections for the Executive and Regional Representatives to be held within four years of the previous election but does not fix the specific day on which the election is to be held; and

WHEREAS the *Saskatchewan Métis Elections Act, 2007* is proposed to be amended to define "Election Day" as the day fixed by resolution of the Métis Nation Legislative Assembly (MNLA);

THEREFORE BE IT RESOLVED THAT the Métis Nation – Saskatchewan (MN-S) Provincial Métis Council recommend to the MNLA that May 24, 2025 be fixed as election day for the election of the Executive and Regional Representatives of the MN-S.

9.3 Appointment of the Registrar

WHEREAS the *Métis Nation of Saskatchewan Citizenship Act*, Article 2.12, states that the "Registrar" shall mean the "Registrar appointed by the Métis Nation Legislative Assembly to administer the Central Registry" (Amended September 9, 2008);

THEREFORE BE IT RESOLVED THAT the Provincial Métis Council recommend that Deb Donaldson be appointed as the Métis Nation — Saskatchewan Registrar for the term of April 1, 2024 — March 31, 2026.

9.4 Prince Albert Housing Project

Related information (provided with the agenda): "Resolution on Prince Albert Housing Project"

Jason Mercredi, Director of Social Infrastructure, reviewed the objective of the Prince Albert Housing Project and Rent-to-Own pilot program, to support citizens who may be unable to secure a mortgage.

It was MOVED (Loretta King) and SECONDED (Sherry McLennan)

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language – inclusive of knowledge keepers, Elders, Youth and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS the Ministry of Housing works across all MN-S ministries to create a collaborative process to review new and existing programs;

WHEREAS the Ministry of Housing has an anticipated surplus of \$6,926,951.20 from a number of sources including the First Time Home Buyers fund (\$6,108,052.21), Emergency Repair fund (\$506,866.65), Training and Capacity (\$116,000.00), and the Housing Conference (\$196,032.34);

WHEREAS the Ministry of Housing has developed a Rent-to-Own pilot program;

WHEREAS the Ministry of Infrastructure is developing a subdivision in Prince Albert;

WHEREAS there are MN-S citizens that face barriers entering into home ownership and the Ministry of Housing strives to create economic and social prosperity for all citizens; and

WHEREAS the Finance Committee recommends to the PMC and is in support of homeownership opportunities for Metis citizens and addressing housing shortages;

THEREFORE BE IT RESOLVED THAT the PMC approve the reallocation of surplus funds in the 2023-24 fiscal year in the amount of \$6,926,951.20 within the Housing portfolio, to be utilized for a Rent-to-Own pilot program in Prince Albert, Saskatchewan.

The following item was considered during the February 22, 2024 In-Camera Meeting.

It was MOVED (Brent Digness) and SECONDED (Glen McCallum)

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values, and language – inclusive of knowledge keepers, Elders, Youth, and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS the Clarence Campeau Development Fund (CCDF) is an affiliate of the MN-S, and the PMC has the authority to approve by resolution, appointments to the CCDF Board of Directors;

WHEREAS the CCDF, through a process defined in their policies and procedures, shall appoint a Nominations Committee to identify a list of qualified candidates to fill any vacancies on its Board of Directors; and

WHEREAS the MN-S through a motion of the PMC will appoint individuals to fill positions available on the CCDF Board of Directors, from the names provided by the Nominations Committee;

THEREFORE BE IT RESOLVED THAT the PMC approve the appointment of Rebeca Johnstone and Tony Playter to the CCDF Board of Directors for a term of three years effective immediately, ending March 31, 2027.
