7.1 Adoption of the January 25, 2025, Special MNLA Order of the Day

During discussion, it was confirmed that:

- Only items on the approved MNLA Agenda will be considered at the January 25, 2025 MNLA
- The MNLA Resolution #MNLA241102-01, which suspended specific Rules of the House, applied exclusively to the November 2-3, 2024 MNLA.

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language - inclusive of knowledge keepers, Lii Vyeu Moond (the "Old Ones" or "Elders"), Youth, Women, and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS the PMC, at their duly held meeting on November 18, 2024, resolved that a Virtual Métis Nation Legislative Assembly (MNLA) would be held on January 25, 2025;

WHEREAS Articles 6.2 and 6.3 of the *Métis Nation of Saskatchewan Legislative Assembly Act,* 1999 (the *Act*), as amended, directs the Clerk of the MNLA, as defined in Article 2.4 of the *Act*, to draft an agenda for the MNLA as directed by the PMC, and to compile the necessary documentation for the Order of the Day; and

WHEREAS the Order of the Day is hereby proposed for the MNLA to be held on January 25, 2025;

7.2 Recommendation of the Complaints Officer and Adjudicator for the 2025 MN-S Election

Related information: Draft Resolution titled, "Recommendation of the Complaints Officer and Adjudicator"

It was MOVED (Loretta King) and SECONDED (Marg Friesen)

WHEREAS Article 116 of the *Saskatchewan Métis Elections Act, 2007* (the *Act*) provides that the Métis Nation Legislative Assembly (MNLA) shall appoint and set the term for a Complaints Officer to enforce compliance with the *Act*;

WHEREAS Article 120 of the *Act* provides that the MNLA shall appoint and set the term for an Adjudicator to hear all complaints referred by the Complaints Officer and render a decision that is final and binding;

WHEREAS the Provincial Métis Council (PMC) has recommended that the date of the Métis Nation – Saskatchewan (MN-S) Election be set for May 24, 2025 (PMC Resolution #240222-04), which is pending approval by the MNLA at their virtual Assembly on January 25, 2025;

WHEREAS it is past practice that the PMC recommends the individuals for the roles of Complaints Officer and Adjudicator as outlined in the *Act*, subject to the approval of the MNLA of those appointments;

THEREFORE BE IT RESOLVED THAT the PMC recommends the following appointments for the roles of Complaints Officer and Adjudicator for a term of one year for the 2025 Election, subject to approval by the MNLA:

- Complaints Officer: Lorne Gibson

- Adjudicator: Gordon Kirkby

BE IT FURTHER RESOLVED THAT the PMC confirms the appointments of the roles of Complaints Officer and Adjudicator are interpreted within the meanings contained in the *Act*, including the exercise of any administrative powers required to fulfill the duties assigned within the *Act*; and

BE IT FURTHER RESOLVED THAT the PMC recommends that a resolution appointing the Complaints Officer and Adjudicator and terms of appointment pursuant to the *Act* be considered at the virtual MNLA scheduled for January 25, 2025.

7.3 Revision of Designated Signing Authorities

An overview was provided regarding recent adjustments within the Department of Finance necessitating the reassignment of signing authorities.

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language - inclusive of Knowledge Keepers, Lii Vyeu Moond (the "Old Ones" or "Elders"), Youth, Women, and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS the MN-S is committed to promoting transparency and integrity in all aspects of government operations, including prudent and accountable use of MN-S funds;

WHEREAS on December 9, 2024, Ayyaz Ahmed, a designated signing authority, returned to the position of Manager of Accounting with MN-S, following the employment of Echo Qin as Director of Finance; and

WHEREAS the Finance Committee recommended that Echo Qin replace Ayyaz Ahmed as a designated signing authority at their meeting on December 16, 2024;

THEREFORE BE IT RESOLVED THAT the PMC approves the removal of Ayyaz Ahmed as a designated signing authority for MN-S banking documentation and designates Echo Qin as his replacement; and

BE IT FURTHER RESOLVED THAT the PMC confirms that MN-S banking-related documentation be signed by any two of the following signing authorities:

- Glen McCallum, President
- Marg Friesen, Minister of Finance
- Richard Quintal, Chief Executive Officer
- Matthew Vermette, Chief Operating Officer
- Echo Qin, Director of Finance.

8. Proposed SaskMétis Economic Development Corporation (SMEDCO) Governance Model Related information:

- Presentation titled, "Building a Bright Future: Proposed Governance and Management Model for SMEDCO"
- Draft Resolution titled, "Endorsement of the Proposed Model and Roadmap for SMEDCO Governance and Management"

Craig Gates, MNP LLP, reviewed the information provided, including governance and management recommendations, and components to consider as part of a long-term agreement between SMEDCO and Clarence Campeau Development Fund (CCDF). It was noted that a report on the material presented, would be provided following the meeting.

During discussion, comments were offered on:

- Recognizing SMEDCO as an MN-S government entity rather than an MN-S Affiliate
- Projected savings of \$703,095 anticipated through an integrated management model between SMEDCO and CCDF
- Consolidating the application process for SMEDCO and CCDF into a streamlined system
- Maintaining distinct Boards of Directors for SMEDCO and CCDF, with overlapping membership
- The current use of the CCDF building which accommodated all operations; the previously-used SMEDCO building remained unoccupied
- Adjusting the structure of the Board of Directors to include representatives from North, Central and Southern Saskatchewan, the MN-S Minister of Economic Development, and appointments approved by the PMC
- Transitioning Muskwa Development Corporation, from SMEDCO to MN-S
- Discussion with Canada on the retention of unspent economic development funding.

It was MOVED (Brent Digness) and SECONDED (Mervin "Tex" Bouvier)

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language - inclusive of knowledge keepers, Lii Vyeu Moond (the "Old Ones" or "Elders"), Youth, Women, and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS, on January 16, 2024, the PMC resolved to remove certain Board Members from the SaskMétis Economic Development Corporation (SMEDCO) Board of Directors and appoint an interim Board. This decision was made to address serious governance and operational challenges within SMEDCO, by reviewing and modernizing the governance practices and structure of the organization;

WHEREAS representatives of MNP LLP and Clarence Campeau Development Corporation (CCDF) presented to the PMC outlining considerations for a future model for SMEDCO and input was provided by the PMC on the presentation;

WHEREAS the PMC requested that the MN-S Chief Operating Officer prepare a draft resolution for consideration, outlining a future proposed model for SMEDCO (PMC Request for Action #RFA-IC-240419-02);

WHEREAS MNP LLP has submitted a report for consideration to the PMC titled "Proposed Model and Roadmap for SMEDCO Governance and Management" (the "Report") that provides a number of recommendations for the management and governance of SMEDCO; and

WHEREAS the PMC has reviewed the Report and is in support of the recommendations contained therein;

THEREFORE BE IT RESOLVED THAT the PMC endorses the recommendations in the Report received from MNP LLP; and

BE IT FURTHER RESOLVED THAT this resolution may be shared with the public upon the completion by all parties of a new agreement regarding the governance and management framework for SMEDCO.

WHEREAS Article 5 of the *Métis Nation of Saskatchewan Legislative Assembly Act, 1999*, directs the Provincial Métis Council (PMC) to appoint a Speaker and Deputy Speaker for the Métis Nation Legislative Assembly (MNLA), which must be ratified by the MNLA;

WHEREAS the MNLA, at their duly held meeting on May 27, 2023, appointed John Lagimodiere and Merelda Fiddler-Potter, to two-year terms as Speaker and Deputy Speaker, respectively; and

WHEREAS Merelda Fiddler-Potter has since resigned from the Deputy Speaker position;

THEREFORE BE IT RESOLVED THAT the PMC recommends the appointment of Mike Nolin as Deputy Speaker for the January 25, 2025 MNLA; and

FURTHER BE IT RESOLVED THAT the PMC recommends that the MNLA ratify the appointment of the Deputy Speaker for the January 25, 2025 MNLA at the next sitting of the MNLA.
