Questions and Answers

1. Q: Will the students in Buffalo Narrows be building the landing and steps.

A: No, due to probable discrepancies in elevations on site, the landings and stairs for the two (2) Tiny Homes built by Others will be the responsibility of the Proponent and should be included in

the pricing.

2. **Q**: In the drawings it is not clear where the meter is to be installed on the building. Where would that be installed ? Will need to know for each of them.

A: Site plans have been provided for each location including building orientations. Proponents should plan the meter install location in order to follow electrical code and SaskPower requirements.

3. **Q**: Do the ceilings over the bathroom and utility need finish on the top?

A: Both the bathroom and utility room ceilings should be finished with appropriate materials.

4. Q: wood stove model number is not correct but we did find the option your looking for it simply is missing a 1

A: The corrected specification within the "Tiny Home Mechanical Package" section should read:

"Cast iron wood stove US Stove Co. Model : US**1**269E or equivalent to be confirmed for sizing and appropriate use case by the Proponent. Final model to be approved by MN-S. Wood stove, chimney, and accessories to be CSA, UL, UL-C approved, and installed by a WETT approved installer, with all required inspection certificate provided for insurance."

5. Q: appliances include black options and wondering if they can all be white?

A: Black appliances are required.

6. **Q**: The two homes that are being built in Buffalo Narrows will these be complete including electrical service ?

A: The two Tiny Homes being built in Buffalo Narrows will be fully wired for electrical, but will require connection to electrical services once on site. Site plans have been provided for each location including building orientations. Proponents should plan the meter install location in order to follow electrical code and SaskPower requirements.
