1. CALL TO ORDER

John Lagimodiere, Chair, called the meeting to order at approximately 1:00 p.m. and acknowledged the traditional lands on which the meeting was being held.

A roll call was conducted, and it was confirmed that a quorum was present.

During discussion, it was requested that the Minutes of the January 21, 2025 PMC Minutes be removed from the Consent Agenda, to enable their consideration. President McCallum acknowledged recent and upcoming events, and commented on:

- Focusing PMC Meetings and MN-S Assemblies on the updates prepared on priority issues
- Recognizing the Citizenship Registry as the heartbeat of the MN-S
- Advancing reconciliation and fostering effective governance for the well-being of MN-S citizens.

6. CONSENT AGENDA

In response to a question raised regarding the omission of a verbatim statement from the draft Minutes of the January 21, 2025 PMC meeting, Hilary Peterson, Acting Senior General Counsel / Deputy Chief, clarified that PMC minutes generally did not include verbatim statements from attendees, and that doing so would be inconsistent with established practice.

The Provincial Secretary clarified that Request for Action #RFA-250121-03, in the Draft Minutes of the January 21, 2025 Meeting, pertained to all budgets related to MN-S self-government agreements.

It was requested that staff distribute to the Provincial Métis Council, details of all budgets related to self-government agreements signed by the MN-S.

8. RESOLUTIONS

8.1 Gabriel Dumont Institute /Board of Governors Appointment for NR1

Related information (provided with the agenda):

It was MOVED (Laura Burnouf) and SECONDED (Mervin "Tex" Bouvier)

WHEREAS the *Constitution of the Métis Nation—Saskatchewan*, Article 5.3 states that Regional Councils make appointments to Affiliates at the Provincial level;

WHEREAS the Gabriel Dumont Institute of Native Studies and Applied Research (GDI) invited applications for the GDI Board of Governors to fill the vacant position in Northern Region 1, in an ad shared from September 2024 to December 2024; and

WHEREAS Northern Region 1 at their duly held meeting on January 28, 2025, recommended that Glenn Lafleur sit on the GDI Board of Governors representing Northern Region 1;

THEREFORE BE IT RESOLVED that the Provincial Métis Council ratify the appointment of Glenn Lafleur to represent Northern Region 1 on the GDI Board of Governors.

8.2 Return of MN-S Owned Assets Before the 2025 MN-S Election

Related information (provided with the agenda): Draft Resolution, "Return of MN-S Owned Assets Before the 2025 MN-S Election"

During discussion, comments were offered on:

- Ensuring accountability and transparency in managing MN-S assets, including those assigned to elected officials
- Allowing sufficient time for staff to reconcile final credit card statements with expenditures, and ensure compliance with reporting requirements

- Clarifying that the proposed resolution applied to all MN-S assets assigned to Executive and Regional Representatives, excluding MN-S employees.

In response to questions raised, it was confirmed that while most MN-S staff were regular employees, some had ongoing or limited contracts. During the election period, operations would continue as usual, with no new announcements, events, or citizen engagements; spending would be restricted to existing funding authorities and the approved budget.

It was MOVED (Marg Friesen) and SECONDED (Billy Kennedy)

WHEREAS the Métis Nation – Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language – inclusive of knowledge keepers, Lii Vyeu Moond ("the old ones" or Elders), Youth, Women and distinctive resources – which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS it is past practice that MN-S owned assets assigned to the Executive and Regional Representatives are returned before an MN-S Election;

WHEREAS an MN-S Election for Executive and Regional Representatives has been called for May 24, 2025 (Resolution #MNLA250125-04); and

WHEREAS the Finance Committee resolved at their meeting on January 29, 2025, to recommend to the PMC that Executive and Regional Representatives return MN-S owned assets before the MN-S Election (Resolution #FC-250129-05);

THEREFORE BE IT RESOLVED THAT the PMC approves that the following MN-S owned assets currently assigned to Executive or Regional Representatives be returned by March 14, 2025, to the MN-S head office, by 12:00 p.m. to allow for sufficient time for reconciliation of accounts:

- Vehicle rentals
- MN-S owned vehicles
- Credit cards
- Fleet cards
- Gas cards; and

FURTHER BE IT RESOLVED THAT the PMC approves that all other MN-S owned assets assigned to Executive and Regional Representatives including cell phones, laptops, chargers, iPads, and other accessories be returned to MN-S head office by 12:00 p.m. on April 17, 2025.

It was requested that the Finance Department report back to the Provincial Métis Council when all MN-S owned assets listed in Resolution #250218-04 have been returned by Executive and Regional Representatives.

Request for Action (RFA-250218-03)

It was requested that the Finance Department provide an updated list of MN-S owned assets to the Provincial Métis Council.

8.3 Setting the Dates for the 2026-2027 MNLAs

Related information (provided with the agenda): Draft Resolution, "Setting the Dates of the 2026-2027 Métis Nation Legislative Assembly"

Scheduling future MNLAs aligned with past practice and allowed time to secure venues.

It was MOVED (Michelle LeClair) and SECONDED (Glen McCallum)

WHEREAS Article 3.10 of the *Constitution of the Métis Nation—Saskatchewan* authorizes the Provincial Métis Council to set the date and place for each sitting of the Métis Nation Legislative Assembly (MNLA);

THEREFORE BE IT RESOLVED that MNLAs be held at Prairieland Park, 503 Ruth Street West, Saskatoon, Saskatchewan, on the following dates:

- 2026:
 - Spring 2026 MNLA: May 22-24, 2026
 Fall 2026 MNLA: November 20-22, 2026
- 2027:
 - Spring 2027 MNLA: May 28-30, 2027Fall 2027 MNLA: November 19-21, 2027.

Change in Chair

Matt Vermette, Chief Operating Officer, assumed the Chair for consideration of the next agenda item.

8.4 Appointment of the MNLA Speaker and Deputy Speaker

Related information (provided with the agenda): Draft Resolution, "Appointment of Speaker and Deputy Speaker for Métis Nation-Saskatchewan Legislative Assembly"

During discussion, comments were offered on:

- Potential considerations related to selecting a Speaker and Deputy Speaker, including encouraging gender balance to ensure diversity in these roles, and publicly posting the positions, to provide MN-S citizens an opportunity to apply
- Clarifying that:
 - The appointment of John Lagimodiere as Speaker would be a renewal, while the appointment of Mike Nolin as Deputy Speaker would be a new appointment
 - The Speaker and Deputy Speaker positions were last advertised approximately two years ago, but no applications were received
- Appointing for 2025 only, to allow the incoming PMC to make longer-term appointments.

Health Break

The meeting recessed at 2:35 p.m. and reconvened at 2:55 p.m.

It was MOVED (Brent Digness) and SECONDED (Glen McCallum)

WHEREAS Article 5 of the *Métis Nation of Saskatchewan Legislative Assembly Act, 1999*, directs the Provincial Métis Council (PMC) to appoint a Speaker and Deputy Speaker for the Métis Nation Legislative Assembly (MNLA), which must be ratified by the MNLA;

THEREFORE BE IT RESOLVED THAT the PMC appoints John Lagimodiere as Speaker and Mike Nolin as Deputy Speaker of the MNLA, for the next MNLA in 2025.

8.5 Amending the Date of the July 2025 MNLA

Related information (provided with the agenda): Draft Resolution, "Amending the Date of the July 2025 MNLA"

It was MOVED (Marg Friesen) and SECONDED (Glen McCallum)

WHEREAS the Métis Nation –Saskatchewan (MN-S) recognizes the distinctiveness of Métis identity, culture, values and language -inclusive of knowledge keepers, Lii Vyeu Moond ("the old ones" or Elders), Youth, Women and distinctive resources –which is incorporated into proposals and decisions of the Provincial Métis Council (PMC);

WHEREAS Article 3.10 of the *Constitution of the Métis Nation –Saskatchewan* authorizes the PMC to set the date and place for each sitting of the Métis Nation Legislative Assembly (MNLA);

WHEREAS the PMC at their duly held meeting on January 21, 2025, set the date for a session of the MNLA of July 4-6, 2025, pending venue availability (Resolution #250121-03);

WHEREAS to accommodate a July MNLA date, planning and notices would occur during the election period, defined in the *Saskatchewan Métis Elections Act, 2007* as 35 days before election day, which is not feasible due to election period restrictions on the MN-S public service; and

WHEREAS Prairieland Park, 503 Ruth Street West, Saskatoon, Saskatchewan, is a trusted partner of the MN-S in holding MNLAs and cannot accommodate the July 4-6, 2025, dates;

THEREFORE BE IT RESOLVED THAT an MNLA be held at Prairieland Park, 503 Ruth Street West, Saskatoon, Saskatchewan, on September 5-7, 2025, instead of July 4-6, 2025.

8.6 Elected Official Harassment Policy

Related information (provided with the agenda): Resolution provided "Elected Official Harassment Policy"

Riva Farrell Racette, Legal Counsel, MLT Aikins LLP, reviewed the proposed Elected Official Harassment Policy, designed to safeguard PMC members and officials while establishing a formal process for handling complaints. Additional comments were offered on:

- Similar policies from other governments and organizations that informed the policy
- The recommendation that the policy should not be implemented retroactively
- Potential conflicts between the proposed policy and the Handbook for the Executive, Ministers and Members of the PMC and Interim Code of Conduct Conflict of Interest Policy
- The scope of the proposed policy, which would not apply during official proceedings such as PMC meetings or an MNLA
- Potentially incorporating the proposed policy into a more comprehensive, updated Code of Conduct – Conflict of Interest Policy
- "Tabs" in the draft Elected Official Harassment Policy that refer to comments and considerations provided by legal counsel, not intended to form part of the final document.

The draft resolution was introduced to approve the "Elected Official Harassment Policy". During discussion, comments were offered on:

 Resolving inconsistencies between the proposed policy and the current Handbook for the Executive, Ministers and Members of the PMC and Interim Code of Conduct - Conflict of Interest Policy

- Contradictions in the proposed policy, for example who is the "Chair of the PMC", and further clarification regarding the rights of a complainant or respondent
- Scheduling a PMC Information Session to review and clarify the policy, given its priority
- Regarding the *Handbook for the Executive, Ministers and Members of the PMC*, the need for:
 - o Adherence to current, established processes
 - An update from the HR Committee on proposed revisions
- The current scope of the proposed policy, which would be applied in favour of, and enforceable against, members of the PMC; in contrast to the scope of the MN-S Public Service Human Resources Manual, which every MN-S employee had signed.

With the consent of the Mover and Seconder, the draft resolution presented on the "Elected Official Harassment Policy", was withdrawn and would be considered at a future PMC Meeting.

Request for Action (RFA-250218-04)

It was requested that staff schedule a virtual PMC Information Session on February 21, 2025, to review the proposed "Elected Official Harassment Policy".

9. FINANCE UPDATE

9.1 Financial Accountability for Elected Officials

Marg Friesen, Minister of Finance, reviewed the MN-S internal travel policy for elected officials, and the results of a recent internal review of expenditures, which identified instances of some incorrectly coded or unauthorized expenses. It was agreed that this matter could be further considered during the in-camera discussion.

10. CONCLUSION

It was MOVED (Mervin "Tex" Bouvier) and SECONDED (Leonard Montgrand)

That the February 18, 2025, Métis Nation – Saskatchewan Provincial Métis Council Meeting now conclude, for an in-camera discussion.
