PMC members were welcomed to contact Matt Vermette, Chief Operating Officer, with questions related to UPIP funding or the processes and requirements related to accessing UPIP funding. It was further noted that, as requested, arrangements could be made for MN-S' senior staff to attend Regional Council Meetings to convey updates on current MN-S' programs and initiatives.
